394. APOLOGIES FOR ABSENCE

Apologies for absence were received from Cllrs. T. Bowen, T. J. Jones (Cllr. J. S. Phillips deputising), A. J. Rogers (Cllr. S. N. Lewis deputising) and W. V. Thomas (Cllr. H. J. Evans deputising).

395. MEMBERS' DECLARATIONS OF INTEREST

No declarations of interest were made.

396. WEBSITE DEVELOPMENT

Members considered the report of the Deputy Clerk (Administration) on re-building the Council's website.

The present website was designed in approximately 2005. With the exception of regular updates and posting of information the 'look' had remained the same. The way people view websites had changed with the introduction of smart phones and tablets. Social media was an increasingly popular means of driving traffic to and from an organisation's website. The current format/website did not help in the facilitation of this.

There had been issues in uploading large PDF documents, agendas of multiple meetings on the same date together with the need for specialist software to update the website.

It was proposed that the Website Framework Design (Content Management System (CMS)) would be built on the popular WordPress framework. This would allow full control over the pages within a strict structure of design styles.
