**104. ACCESS TO INFORMATION ON COMMUNITY AND TOWN COUNCILS**

Members considered the draft consultation document from the Scrutiny, Democracy and Participation Team, Welsh Government.

In accordance with the Local Government (Democracy) (Wales) Act 2013, Sections 55 to 58 of the Act were concerned with access to information about Community and Town Councils. The Act required Community and Town Councils to have websites; publish notices and papers electronically; and to publish their register of Members' interests electronically.

The Council must publish electronically information about each of its members, including a list of council members, each member's name, their contact details, political affiliation (if any) and any office held or committee they belong to within the Council. If the community concerned was divided into community wards, the ward each member represents must be shown.

The Council must also publish electronically the following:-

- Minutes of meetings;
- audited accounts;
- public notices; and
- notices of meetings.

Following discussion, it was

**RESOLVED** that the Clerk responds to the set of accompanying consultation questions with them being returned to the Scrutiny, Democracy and Participation Team, Welsh Government, indicating full support for the proposals.

**105. PUBLIC HEALTH WHITE PAPER  
LISTENING TO YOU: YOUR HEALTH MATTERS**

Members considered a consultation document from the Head of Health Protection Division, Welsh Government.

On 2 April, 2014, the Welsh Government published a consultation document on the Public Health White Paper which set out a series of proposals for legislation to help further improve and protect people's health and wellbeing in Wales.

Chapter 5 of the White Paper asked for views on the proposal to place a duty on each local authority (County Council) to develop a strategy on the provision of and access to toilets for public use in their area.

Following discussion, during which Members raised general concerns and issues regarding public toilet provision it was

**RESOLVED** that the Clerk be authorised to complete the accompanying consultation questions articulating Members' views and observations while confirming the Council's general support for a duty to be placed on local authorities to develop a strategy for the provision of and access to toilets for public use in their area.

**106.           DYFED POWYS PUBLIC INVITED  
TO BE THE JUDGE**

Members received correspondence from the Dyfed Powys Police and Crime Commissioner, requesting the Council's response to how local justice was delivered for minor offences.

The Commissioner was keen to garner community views as to how offences such as minor criminal damage and low value theft could be dealt with. A recent change in the law allowed victims to have a say in the punishment of their offender.

The new community remedy would be introduced across Carmarthenshire, Ceredigion, Pembrokeshire and Powys this autumn. Victims would choose a punishment from a list of options. It was hoped the community remedy would deliver swift justice and see minor offending nipped in the bud.

Following discussion, it was

**RESOLVED** that an invitation be sent to the Dyfed Powys Police and Crime Commissioner to attend a future Council meeting to discuss the initiative in further detail.

**107.           PUBLIC BODIES (ADMISSION TO MEETINGS) ACT, 1960**

**RESOLVED** that in view of the confidential nature of the business to be transacted, the following matter be considered in private and that the power of exclusion of the public under Section 1(2) of the Public Bodies (Admission to Meetings) Act, 1960 be exercised.

**108.           LOCAL GOVERNMENT PENSION SCHEME**

Members were circulated with a letter from the Pensions Manager, Carmarthenshire County Council informing of the employers contribution rate payments from April 2015 through to March 2018.
