## 199. PLANNING APPLICATIONS TOWN AND COUNTRY GENERAL DEVELOPMENT PROCEDURE ORDER 1995

Consideration having been given to planning applications received, it was

Whilst the Council supports the development proposal in principle Members based their decision on the loss of essential parking space on matchdays at Parc y Scarlets. Local Members referred to the current problems associated with indiscriminate parking of vehicles in the locality. The removal of this parking area would exacerbate the situation with the proliferation of unauthorised car parking spreading out over the area giving rise to access and highway safety issues in the immediate vicinity at the retail parks and also residential areas in the Pemberton area which overlooked and or were near to the stadium. The Council would be minded to support the application if in the first instance additional match day parking was identified and put in place to serve as a direct replacement for the parcel of land in question.

Consent was required to construct a public house/restaurant.

Consent was required for a conservatory to be constructed to the side of the dwelling.

(1) The site was located on a designated floodplain as a C2 flood zone.

(2) The application stated that surface water would be disposed of via the mains sewer. This was no longer acceptable because the sewerage network was already full to capacity. Development proposals were now required to identify other water disposal methods to prevent surface water from entering the main sewer.

(3) There were also Health and Safety concerns with the site being located in close proximity to a Chemical Plant.

Outline consent was required for demolition of existing building and redevelopment of site for residential use for 97 dwellings.

# 200. PLANNING APPLICATION DETERMINED UNDER THE CLERK'S DELEGATED POWERS

## 201. PROPOSED ROAD SAFETY SCHEME - SANDY ROAD, LLANELLI AND BASSETT TERRACE PWLL

Consideration was given to email correspondence received from the Traffic Engineer at Carmarthenshire County Council informing of a proposed road safety scheme for Sandy Road, Llanelli and Bassett Terrace, Pwll. The County Council had secured a £55,000 Road Safety Grant for the provision of various road safety measures along the said route. Following discussion it was

**RESOLVED** that the scheme proposals be supported.

## 202. PROPOSED WAITING RESTRICTION AND STREET PARKING PLACES – LLANELLI

Members considered correspondence received from the Head of Administration and Law, Carmarthenshire County Council regarding a public notice to introduce proposed waiting restrictions and street parking arrangements for various roads in the Council's administrative area. The roads in question were Elgin Road, Pwll, Cae Rhos and Gelli Road, Llwynhendy and Heol Cropin, Dafen Parc Industrial Estate. Members were supportive of the proposals to help improve highway safety but commented about inadequate on site car parking for business users at Heol Cropin and felt that this should be addressed when introducing the proposals and it was

**RESOLVED** that the proposals be supported but the provision of additional parking spaces for businesses in Heol Cropin, Dafen Industrial Park be investigated by Carmarthenshire County Council.

## 203. WASTEWATER SYSTEM – BYNEA

Members considered correspondence received from the External Communications Manager, Welsh Water, informing of plans to replace 1.2 kilometres of sewer on Berwick Road, Parc Berwig and Heol y Bwlch. Work would also be carried out on private land behind Parc Berwig and Bynea Business Park. The work would help to alleviate flooding to properties during periods of heavy rainfall. Members were informed the original commencement date had been put back from 24 September to 29 October, 2012, owing to the need to carry out a survey along the entire route following the discovery of an unexploded bomb, recently unearthed in Bynea. It was anticipated the work, once started, would take approximately 49 weeks to complete.
