# 267. LLANELLI FAIRTRADE

# **RESOLVED** that:

- 1. The Council shall once again consider supporting the principle of Fairtrade on the basis that there was a greater range of Fairtrade products now available so that Fairtrade refreshments can be purchased and used in the Members' room for a trial period of six months.
- 2. The local Fairtrade movement be notified that Cllr. S. M. Caiach has been appointed to represent the Council on Llanelli Fairtrade.
- 3. Llanelli Fairtrade's request to make use of a room at Vauxhall Buildings be approved in principle provided its meetings did not interrupt the Council's normal business arrangements. Furthermore, and in this regard a suggestion be made to the local Fairtrade representative that the option of sharing meeting space with Llanelli Town Council be investigated with meetings alternating between the two Councils.

# 18. MATTERS ARISING LLANELLI CREMATORIUM

From the 1 October Llanelli Joint Burial Advisory Committee would replace Llanelli Joint Burial Authority and would act in an advisory capacity to the parent councils.

#### 23. CHILD BURIAL FEES

Members considered correspondence form the Director of Local Government, Welsh Government date 28 July 2017 addressed to the Chief Executive of the Welsh Local Government Association regarding Welsh Minister's commitment to remove child burial fees from Wales altogether. After a lengthy discussion it was

RESOLVED that the correspondence be noted and to await further developments from the Welsh Government on the matter. However, as an interim measure and as a means of seeking further clarification, the Technical and Burial Services Manager be authorised to raise the subject matter with the South Wales Bereavement Services Forum in order to garner wider opinion on the potential ramifications for the community and town council sector.
