360. PUBLIC NOTICE – PROPOSED ROAD HUMP – HEOL Y BWLCH, BYNEA

Further to Minute No. 321, Members considered correspondence from Legal Services, Carmarthenshire County Council informing of a notice given in accordance with Section 90C of the Highways Act 1980, of an intention to exercise its powers under Section 90A of the Highways Act 1980 to construct road humps, complying with the Highways (Road Humps) Regulations 1999, on Heol y Bwlch, Bynea. The proposed nature, dimension and locations of the road humps were as follows:

Туре	Dimensions	Location
Speed Cushions	65mm high 1650 mm wide 2000mm	B4297, Heol Y Bwlch, Bynea. 112 metres South East of the centre of its junction with Clos Y Gerrdi.
Round Top Hump	75mm high (with permitted maximum legal height being 100mm). Tapered humps not completely kerb to kerb, with a curved top profile 3.7m long.	B4297, Heol Y Bwlch, Bynea outside property No. 23.

The road humps were considered necessary in the interest of road safety to lower existing vehicle speeds along this length of public highway to ensure abeyance with the 30mph speed limit.

RESOLVED that the traffic calming measures be supported in the interest of highway safety.
