299. CLLR. G. N. R. EDWARDS

The Chairman announced that Cllr. G. N. R. Edwards had sadly passed away on 1 December, 2014, and the Council's thoughts and prayers had been extended to his widow, his two sons and to his wider family.

The Chairman stated Cllr. Edwards was an uncle to Cllr. S. N. Lewis and extended her deepest sympathy to Cllr. Lewis.

It was because of that family relationship with Cllr. Lewis that Cllr. Edwards was affectionately referred to occasionally as 'Uncle George' at Council committee meetings. Cllr. Edwards would not only be a great loss to his family but also to the Council and community at large.

The Chairman then referred to Cllr. Edwards' public service record having been elected on to the Council in May, 2012. During his time on the Council he diligently represented the residents of Hengoed Ward on the following committees:

Cllr. Edwards was also a County Councillor. The Chairman remarked that Cllr. Edwards always conducted himself in an exemplary manner and he was a true gentleman. He went about his community work with pride and enthusiasm. Indeed, Cllr. Edwards had been instrumental in the asset transfer of Pwll Pavilion and recently brokered a meeting to resolve road safety issues at Brynteg. He was also heavily involved in the National Eisteddfod preparations. There were many more issues where Cllr. Edwards had a positive and lasting impact and further tributes to Cllr. Edwards would manifest between now and his funeral service which was being held on Thursday, 11 December. Members concurred with the Chairman's remarks.

In remembrance of Cllr. Edwards and as a mark of respect the Chairman requested all present to stand and observe a minute's silence.

303. MATTERS ARISING

(1) COMMUNITY DEVELOPMENT GRANTS

Further to Minute No. 268(2), Cllr. S. L. Davies commented the Minute was inaccurate because it didn't reflect what she said about particular Councillors serving on the Community Development Grants Panel in voting not to support the said grant applications.

In reply the Clerk acknowledged Cllr. Davies' remarks and stated the Minute had been drafted in the way it was presented because Minutes were legal records of the decisions taken at meetings; generally speaking Minutes were not a vehicle for recording personal remarks about the voting patterns of individual Members. This should only occur if for example a recorded vote was requested at the meeting, which wasn't the case in this instance. Ultimately, the Committee as a whole made the decision and not the two individual Members referred to by Cllr. Davies. By way of response, Cllr. Davies reasserted her comments over the accuracy of what she said at the Council meeting and it was

(2) SWANSEA BAY CITY REGION

Further to Minute No. 271, the Clerk informed Members that he had attended the Swansea Bay City Region meeting on 19 November, 2014. The Clerk reported that there was a disappointing turnout at the meeting. He then briefed Members on the current status and role of the city region and how this might alter in the future. It had no powers or budget but was more a body of influence in the field of economic development.

Following on from that meeting, an item had been tabled about the meeting on the agenda of the Llanelli Area Town and Community Council group which met on 26 November, 2014. However, the group was not supportive of the idea of hosting a similar event in Llanelli.

During the ensuing discussion it was felt that the city region initiative was very important and something that Members should monitor with interest and that the matter should be revisited in the future as the concept gained momentum.

Members considered email correspondence received from the Clerk to Llanelli Town Council requesting the potential review of Standing Order 4.1 relating to the quorum for meetings. It had been suggested that in addition to having four members present at meetings to constitute a quorum, at least one member of Llanelli Rural Council and one member of Llanelli Town Council needed to be present.

RESOLVED that in accordance with Standing Order No.30.2, this matter shall stand adjourned without further discussion, to the next ordinary meeting of the Burial Authority, scheduled for 12 November 2014.

36. AUDIT OF ACCOUNTS FOR THE YEAR ENDING 31 MARCH 2014

Further to Minute No. 29 Members received correspondence from Mazars LLP, enclosing the Burial Authority's certified Annual Return together with a copy of the Notice of Conclusion of Audit. The notice was required to be kept on public display for at least 14 days. The notice was dated 25 September 2014. Members were informed that all audit work had now been completed.

37. PUBLIC BODIES (ADMISSION TO MEETINGS) ACT, 1960

RESOLVED that in view of the confidential nature of the business to be transacted the following matters be considered in private and that the power of exclusion of the public under Section 1(2) of the Public Bodies (Admission to Meetings) Act, 1960 be exercised.

38. SCATTERING GARDENS

Members considered the Cemetery Manager's report regarding quotations received from registered Memorial Masons to supply an engraving service for the new memorial plaques on the scattering gardens. The report also sought Member approval for a pricing structure and operating terms. The proposals were as follows:

- (1) Cremated remains shall be scattered over the raised gardens or if preferred around the perimeter of the gardens amongst the lavender borders. Exclusive burial rights were not applicable and would not be issued. The fee for scattering cremated remains would be initially set at £35.00.
- (2) Memorial plaques would be offered for a 15 or 30 year lease period. The lease period could be renewed upon the expiry of the original lease using the

original memorial plaque. The associated fees for installing a memorial plaque shall initially be set at £120.00 for a 15 year lease and £190.00 for a 30 year lease with a £70.00 lease renewal fee. A second inscription fee on the plaques would cost £40.00.

(3) If a ceramic photo plaque was required an additional fee of £50.00 for a photo plaque measuring 5cm x 7cm shall be payable and a fee of £60.00 for a photo plaque measuring 8cm x 10cm.

Following discussion it was

RESOLVED that:

- 1. The proposed pricing structure and operating terms as specified above be accepted.
- 2. The quotation received from B. M. Phillips, 43 Glenalla Road, Llanelli, to cut one simple design from list provided, finished in silver enamel: £29.95. Supply and fit 5cmx7cm ceramic photo plaque £50.00 and supply and fit 8cmx10cm ceramic photo plaque £60.00 be accepted.
 - 39. DIFFERENT COLOUR MEMORIAL GARDEN OF REMEMBRANCE 1

RESOLVED the request received from SM to install a different colour memorial as described in his letter dated 23 September 2014 be approved accordingly. Members confirmed there was to be no change to the existing cemetery rules and regulations to accommodate the request and that any future similar requests would be considered on their individual merit.
