437. PUBLIC NOTICE - (LAY-BYS ON THE A4138 - LLANELLI TO LLANGENNECH ROAD) (PROHIBITION OF DRIVING) ORDER 2015

Further to Minute No. 415, Members received correspondence from the Chief Executive, Carmarthenshire County Council giving notice that Carmarthenshire County Council proposed to make an Order under Sections 1 (1) and 2 (1) to 2 to the Road Traffic Regulation Act 1984 as amended and the Traffic Management Act 2004.

The effect of the Order would be to prohibit any vehicle from proceeding along that length of road as specified below:

Members received correspondence from the Chief Executive, Carmarthenshire County Council giving notice that the County Council proposed to make an Order under Sections 1 (1), 2(1) to (3), 4(2), and 1, 2, 4, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") as amended and Traffic Management Act 2004.

The object of the Order in relation to affected roads in the Llanelli Rural Council area would be to prohibit waiting at any time along the lengths of road specified in Schedule 1 to the Public Notice.
