LLWYNHENDY & PWLL FORMER EDUCATION CENTRES

1. PURPOSE OF REPORT

- 1.1 To provide Members with an information report on recent interaction with Carmarthenshire County Council Corporate Property department regarding its plans for the former education centres at Llwynhendy and Pwll.
- 1.2 To seek Members permission on the next course of action with regards to assessing the viability of retaining these assets for community use.

2. PRESENT POSITION

- 2.1 In recent years up until April 2017, the two education centres situated at Llwynhendy Road and Pwll Road, were occupied by Carmarthenshire County Council Education department however the services have been relocated to Burry Port, leaving the buildings vacant and surplus to use.
- 2.2 The buildings are not on the Community Asset Transfer list and are being considered for commercial sale. If a robust business case is received from the community for an alternative use then it will be given due consideration. There is an expectation that a receipt (capital sum payable) for whoever takes on each property. Sometimes a reduced receipt may be considered.
- 2.3 In order for Carmarthenshire County Council to consider our potential interest and transfer of the asset, they require a business case outlining the following:
 - i. Summary of the Council's intentions / proposals for the buildings;
 - ii. Evidence of need for the Council's proposals and confirmation that they cannot be accommodated elsewhere in the ward;
 - iii. How would the Council fund any revenue and capital costs going forward.
- 2.4 A Valuer from Carmarthenshire County Council Corporate Property department recently met local members and officers at the two buildings to provide a guided viewing of the buildings.
- 2.5 'For Sale' signs are soon to be placed outside each building, however Carmarthenshire County Council is mindful that business plans are being worked on and will take these proposals into consideration prior to a decision being made.
- 2.6 Carmarthenshire County Council has been informed to expect the business cases during midlate September.

3. COMMUNITY ENGAGEMENT

- 3.1 The Council has been involved in the following with regards to Pwll Education Centre:
 - i. On 30 November, 2016, a public meeting was arranged by Cllr. P. Edwards and the Pwll Action Committee at Pwll Education Centre. This was held to check the support of Pwll residents for keeping the building for community use. The meeting was attended by over 50 residents who were in favour of exploring possibilities of keeping the centre. 25 questionnaires about potential building use were collected in order to evidence need. 16 residents put their names forward to volunteer at the hall / form a hall committee;
 - ii. A follow up meeting was held on 30 May, 2017. It was attended by 25 residents who were updated on the situation with regards to the centre. Two actions were agreed: arrange for a site visit of the education centre and start up a petition to be taken around the houses in Pwll;
 - iii. The most recent meeting was held on 4 July, 2017. 504 petition signatures had been collected up to this point (456 door to door, 48 online); see 3.3 regarding the timescale as was agreed at the meeting.
- 3.2 The Council has been involved in the following with regards to Llwynhendy Education Centre:
 - i. 26 residents attended an open meeting at Llwynhendy Library on 20 June, 2017, to discuss the need for a community building. All attendees filled in questionnaires about potential building use in order to evidence need;
 - ii. Llwynhendy has been consulted greatly recently with the Whole Place Plan then followed by Building Communities Trust. The community is stating they want a space that will enable the delivery of well-being services and wish to cater for young people age 11 upwards of which there is no current provision.
- 3.3 The following timescale has been suggested to Carmarthenshire County Council:
 - i. 18 July seek approval of Recreation & Welfare Committee to carry out a structural survey on both the Pwll and Llwynhendy buildings;
 - ii. 1st August deadline for the next edition of the Pwll Bonau Cabbage Patch magazine. The CDO will provide Pwll Action Committee with an update on the R&W Committee meeting and confirm the next public meeting date and venue;
 - iii. During August no council meetings so will discuss the buildings again in September;
 - iv. During August (Pwll) community to keep up momentum and continue with signature collection and put posters up locally to further raise awareness;
 - v. 1st September (Pwll) delivery of Pwll Bonau Cabbage Patch magazine;

- vi. 2nd week in September date t.b.c. (Pwll) hold the next public meeting. Request to be made to hold this in the education centre;
- vii. 19th September present the survey results (if agreed in July) to Recreation & Welfare Committee to decide on next steps;
- viii. After 19 September bar any complications, finalise the business case.

4. LONG TERM IMPLICATIONS

- 4.1 If the building(s) were to be transferred to the Council, it must consider the long term financial costs of any up front renovations to ongoing maintenance.
- 4.2 Taking on Pwll Education Centre won't impact any other community centres in Pwll as there are none. Like in other Council wards, it will give the village its own community hub to run and manage which should lessen the dependency on transport to get to activities in other areas.
- 4.3 Likewise, the Llwynhendy building will need to work with the Trallwm Community Hall committee in order to provide complementary and sustainable services.

5. SUSTAINABILITY AND WELL-BEING CONSIDERATIONS

5.1 The provision of a community building meets the following aims, core values and well-being goals:

6. PUBLIC INVOLVEMENT

- 6.1 Local residents have informed both Carmarthenshire and our Council the need for a community centre in both Llwynhendy and Pwll via meetings, questionnaires, surveys and other consultation methods.
- 6.2 Individuals from both communities have indicated that they are willing to form a committee in order to take on the day to day running of their community centre.

7. COLLABORATION OPPORTUNITIES

- 7.1 Up until now there has been collaboration between local groups like Pwll Action Committee, Invest Local Llwynhendy as well as potential hirers such as the local judo and dance club providers.
- 7.2 There will be future collaboration opportunities via the likes of the local schools, groups, sport clubs, small businesses and public services.

8. PREVENTATIVE MEASURES/CONSIDERATIONS

8.1 To help determine the viability of these assets as future community buildings, consider structural surveys for each building and stick to the timeline as described in 3.3.

9. RECOMMENDATIONS

9.1 That Members approve the Council appoints a surveyor to report on all structural aspects of both Llwynhendy and Pwll former education centres.
