344. BUDGET VIREMENTS

Members considered the report of the Cemetery Manager which recommended the virement of funds from the Council earmarked reserve for the children's play area at Cilsaig, Dafen to support additional works at Pontyates play area and the White Lion Depot. The rationale for the virement was explained to Members and it was,

RESOLVED that

- 1. The budget be increased by £10,000 to £70,000, to ensure a sufficient budget was available for a suitable play area at Pontyates Park;
- 2. a budget of £10,000 to be provided for clearance works for waste disposal at White Lion Depot; and
- 3. an allocation be made in the budgets for the 2017/18 financial year to reinstate the budget of £20,000 for the enhancement of the children's play area at Cilsaig.
