Did not give rise to any environmental concerns generated by the processing of 100 tonnes of hazardous waste as identified in the To mitigate application. against this it was recommended that Carmarthenshire County Council the ensures relevant pollutant control regimes would be properly applied and enforced by the appropriate agencies.

2. The 50 additional vehicle movements per week generated by the change of use had no detrimental impact on the quality of life of Bynea residents and there being no highway safety concerns arising from the increase in traffic movements.

3. The drainage generated from the additional development did not increase the hydraulic load on the public sewer.

334. PUBLIC PATH DIVERSION ORDER 2015 – CARMARTHENSHIRE COUNTY COUNCIL (PUBLIC FOOTPATH 72/35) STRADEY PARK, LLANELLI

Further to Minute No. 171 (27 August, 2013) Members received correspondence from the Countryside Access Officer advising that in August 2013 Carmarthenshire County Council carried out a pre-order making consultation on a proposal to divert the above footpath. No objections had been received during the 28 days consultation period and therefore a Public Path Diversion Order was made on the 5 June, 2015.

During general discussion Members queried the width and surface of the footpath and also the implications of providing unhindered access if it was decided to erect gates along the right of way. The Clerk confirmed that these matters would be brought to the attention of the Countryside Access Officer and it was

RESOLVED that the Order be supported.
