#### 346. APOLOGIES FOR ABSENCE

Apologies for absence were received from Cllrs. A. G. Morgan (Cllr. M. L. Evans deputising) and A. J. Rogers.

#### 347. MEMBERS' DECLARATIONS OF INTEREST

No Declaration of interest were made.

#### 348. ELECTORAL REVIEWS: POLICY AND PRACTICE 2016

Members received correspondence from the Local Democracy and Boundary Commission for Wales in relation to the programmed electoral reviews of all 22 principal Council areas by 2022.

The current programme of electoral reviews would aim to submit recommendations for all 22 Principal Council areas in Welsh Government to be implemented with or without modification, in time for the 2022 local government elections.

The objective of the electoral review was to ensure that within each local authority area, electoral arrangements seeked to achieve parity. Utilising the existing community structure within a local authority, an electoral review would take into account community identities, electoral equality and consultation feedback to ensure that the proposals uphold the interests of effective and convenient local government for the electorate within Wales.

Following discussion, it was

# 349. THE DRAFT ACCOUNTS AND AUDIT (WALES) (AMENDMENT) REGULATIONS 2016

Members received a consultation document from the Local Government Finance Policy Division, Welsh Government on The Draft Accounts and Audit (Wales) (Amendment) Regulations 2016.

The consultation document outlined proposed amendments to the 2014 Regulations which would bring about changes to the timetable for preparing and publishing local government bodies' statement of account. The amendments also proposed changing the requirements around both the publication of pension statement and the display of public notices relating to statements of accounts.

Following discussion, it was

**RESOLVED** that the Clerks be authorised to respond to The Draft Accounts and Audit (Wales) (Amendment) Regulations 2016 highlighting Members' views.

#### 350. PONTYATES POST OFFICE

Correspondence was received from the Regional Network Manager, Post Office, informing of the movement of the current post office branch at Pontyates. The new branch would operate as one of the new local style Post Office branches from the Nisa Local, 13 Heol Y Meinciau, Pontyates.

The new branch would be in line with Post Office specifications, making sure there was sufficient space for the Post Office service to operate alongside the retail offer. The new branch would have level access with a wide door at the entrance and a pedestrian walkway across the garage forecourt to provide a clear route from the roadside and parking areas to the shop entrance. There would also be a designated disabled parking bay close to the shop entrance.
