196. APOLOGIES FOR ABSENCE

Apologies for absence were received from Cllrs. A. G. Morgan, W. V. Thomas and G. H. Wooldridge (Cllr. R. E. Evans deputising).

197. MEMBERS' DECLARATIONS OF INTEREST

Cllr. S. L. Davies declared a person interest in Minute No. 199 (S/30820) as she commented over the matter in her capacity as a County Councillor.

198. CONCRETE SPILLWAY, TRE BEDDROD RESERVOIR (S/30412)

The Chairman welcomed Mr Philip Williams from Carmarthenshire County Council (CCC) to the meeting and invited him to brief the committee on the present situation of planning application S/30412.

Mr Williams began by explaining that the initial engineer report identified the area was prone to over spilling and therefore recommended a spillway be constructed. It was predicted that a 1:1000 storm could cause severe over-spilling and therefore CCC would be faced with a heavy fine if the work was not carried out. It was hoped that the work would commence by the end of this year.

Members raised a number of queries about the construction such as would there be any detriment to the fish population in the pond. Mr Williams explained this had been investigated and it had been confirmed that the fish could remain at the pond and suffer no harm.

Another question asked if the Dam was going to be reinforced, Mr Williams confirmed that it was just a spillway that was to be constructed. A question was raised as to how CCC could put the work out for tender before permission for the work to be carried out was granted. Mr Williams replied, stating the key milestones were completing the design (ARUP), planning permission and seeking tenders for the proposed works (both CCC). These processes were in hand and could run simultaneously. An environmental report was to be submitted as a requirement of the planning process.

The project was a 'stand alone' scheme with influences being the effects of the main river that the spillway would discharge into and the environmental impact of undertaking the works. A numerical model of the potential increases in flow into the main river has been submitted to National Resources Wales (NRW) for consideration.

Mr Williams then addressed risk identification and management. Planning permission or discharge consent might be delayed which would affect the programme and consequently the completion date for the scheme. NRW would be kept informed of any difficulties in completing on time and an extension to the deadline would be requested if any delays were apparent.

The project would be controlled by the County Council's Streetscene with input from the Consultant Division which would oversee management and construction of the project.

The project would be deemed complete when NRW 'sign off' the project stating that the spillway had been constructed to the Reservoir Engineer's satisfaction.

Thereupon, the Chairman thanked Mr Williams for attending and he withdrew from the meeting.

RESOLVED that the application be supported.
