**447. APOLOGIES FOR ABSENCE**

Apologies for absence were received from Cllrs. L. A. Beer, L. J. Butler, D. M. Cundy, M. V. Davies (Cllr. M. L. Evans deputising), T. J. Jones, C. A. Rees and A. J. Rogers (Cllr. S. N. Lewis deputising).

**449. FINANCIAL REPORTS**

**RESOLVED** that the Committee Reports for the Administration and Training Departments to 28 February, 2015, be noted.

**450. SCHEDULES OF PAYMENTS**

Consideration was given to the Schedules of Payments for the Administration and Training Departments for January and February 2015, (copies of which had been previously circulated) which revealed that the expenditure amounted to £131,088.95 and £163,197.86 and £119,586.54 and £111,943.10 respectively.

**451. ACCOUNTS AND AUDIT (WALES) REGULATIONS 2014**

Members received correspondence from the Local Government Finance and Performance, Welsh Government, informing that The Accounts and Audit (Wales) Regulations 2014 replaced the Accounts and Audit (Wales) Regulations 2005 (“the 2005 Regulations”) along with other related amending Regulations.

The 2014 Regulations had provided an opportunity to review, update and consolidate the regulatory regime underpinning local government bodies’ financial reporting and accounting. The changes made included consolidation of all previous amendments, definition of smaller and larger relevant bodies to improve clarity of the requirements for smaller and larger relevant bodies. The threshold for defining a smaller relevant body had been increased to £2.5 million. The Regulations would come into force on 31 March, 2015 and would apply to the current financial year as well as to subsequent ones.

Consequently, the Council would be defined as a “smaller relevant body” under the Regulations as its gross income or expenditure was not more than £2.5 million in the year of account or in either of the two preceding years; the gross income for 2013/14 was £2.25 million.

The main changes to the accounting policies under the 2014 Regulations were:

An Annual Return would be made to the external auditors in lieu of an inspection of the accounts;  
the accounting statement would be presented to Council and not to the Finance and General Purposes Committee.
