Consent was required for a proposed rear first floor bedroom extension.

S/29508 Extension Mr H Thomas 2 Llwyn yr Eos Pemberton Llanelli NO OBJECTION provided: 1. The scale of the development was subordinate in design to the main dwelling. 2. The design was not an incongruous form of development compared to the general street scene.

Consent was required for side extension to dwelling, with front roof elevation (south east) altered for dormer windows.

#### 402. WESTERN POWER DISTRIBUTION – BRECHFA FOREST CONNECTION PROJECT – PREFERRED CORRIDORS ANNOUNCEMENT

Further to Minute No. 142 correspondence was received from Western Power Distribution regarding its preferred corridors announcement in connection with the Brechfa wind farm project.

The correspondence outlined the preferred route corridor selection for stage two of the project. Consultation for stage two would begin in February 2014 and would run for eight weeks.

The next stage of consultation would identify where the overhead power line (also called an alignment) would be put within the preferred route corridors. At this point the Council would be asked to comment on the alignment options for the proposed 132,000 volt line.

**RESOLVED** that the information be noted and to await further developments.

### 403. THE COUNTY OF CARMARTHENSHIRE (WITH THE EXCEPTION OF CARMARTHEN, LLANELLI, AND AMMANFORD), (WAITING RESTRICTION AND STREET PARKING PLACES) CONSOLIDATION (VARIATION NO 15) ORDER 2013

Members considered email correspondence received from the Chief Executive's Office, Carmarthenshire County Council. The email contained details of a public notice in respect of the above Traffic Order.

The effect of this Order was to prohibit waiting at any time on the side of the road specified in the Schedule accompanying the public notice. The roads in the Rural Council's area affected by the Order were as follows:

Name of Roadway	Length Affected
B4309	On the east side
Pontyates	From a point 15 metres south of the centre of its junction with the road leading to Brynderi for a distance of 25 metres in a northerly direction.
Brynderi, Pontyates	On both sides From its junction with the B4309 for a distance of 10 metres in an easterly direction.

**RESOLVED** that the Traffic Order be supported in the interest of highway safety.

#### 404. FOOTPATH WIDENING SCHEME – HEOL LLANELLI, PONTYATES

Further to Minute No. 230 Members considered a letter from the Head of Transport and Engineering, Carmarthenshire County Council dated 9 January, 2014. A footway widening scheme had been prioritised under the County Council's Road Safety / Footway Improvement Programme.

Phase two of the scheme was to be constructed by the Authority's Direct Labour Organisation (DLO) with works expected to commence during January, taking some three weeks to complete.

Members were circulated with a copy of the general arrangement plan indicting the nature and extent of the works.
