411. PROPOSED TRAFFIC CALMING AND 20 MPH ZONE BRYNSIERFEL, LLANELLI

Members were circulated with correspondence from the Head of Transport and Engineering Division, Carmarthenshire County Council, stating that the County Council proposed to introduce traffic calming measures and a 20 MPH zone at Brynsierfel, Llanelli prior to the opening of the re-constructed primary school. This scheme of works would enhance the safety of vulnerable groups such as child pedestrians travelling to and from the school.

412. TEMPORARY ROAD CLOSURE – C2209 MAES YR HAF, HERBERDEG ROAD, CARWAY

Correspondence was received from Head of Transport and Engineering, Carmarthenshire County Council, informing of the temporary road closure of the C2209 Maes Yr Haf, Herberdeg Road, Carway, for a distance of 250 metres in a south-easterly direction.
