445. APOLOGIES FOR ABSENCE

Apologies for absence were received from Cllrs. F Akhtar, L. A. Beer and A. G. Morgan.

446. MEMBERS' DECLARATIONS OF INTEREST

Cllr. D. M. Cundy declared a personal interest in Minute No. 450(2) as he was a Member of the SOSPPAN Campaign Committee.

447. CARMARTHENSHIRE COMMUNITY CHALLENGE

Pursuant to Minute No. 336, the Chairman welcomed Ms Eurgain Powell, Sustainability Officer and Ms Allison Thomas-Mears, Press and Communications Officer, Carmarthenshire County Council to the meeting.

Ms. Powell explained that Carmarthenshire County Council, in partnership with the Llanelli Star and Carmarthen Journal, had launched the Carmarthenshire Community Challenge campaign in September 2012 to encourage communities to reduce their carbon footprint. There was a need to consider the way in which people could reduce their impact on the planet by accepting responsibility for a more sustainable lifestyle including growing their own food, using less energy, biodiversity in the environment, recycling etc. Ms. Powell stated that the campaign had been successful with 25 organisations participating since its inception; such as food growing groups at Llandeilo, Carmarthen, Foodbank and regeneration projects in Llwynhendy and Llanelli. The self-funding campaign was family-friendly; groups joining would receive a welcome pack containing information and advice, there was a Facebook page

and monthly e-newsletter, specialist support and shared information. It was hoped that more groups would join the campaign.

In response to queries raised by Members, Ms. Powell stated that:

- Media involvement would extend to the Ammanford area;
- Employers were not excluded but trade unions were not being targeted. However, contact could be made with regard to training being funded by the TUC upon receipt of information from Cllr. S. M. Donoghue;
- Concerns expressed at the increase in carbon footprint due to patients and support services travelling longer distances as a result of the re-structuring of health services would be raised with Hywel Dda Health Board;
- Schools in general were not being targeted as they already participated in the Eco-Schools programme although some platinum eco-schools had joined the campaign to extend their boundaries;
- The main aim was to raise awareness, enabling and supporting groups to make changes by using their knowledge of the local area.

Ms. Powell added that the Rural Council could participate in the campaign by signposting groups and distributing welcome packs to which specific information on measures individuals could take to reduce energy bills and carbon footprint, insulating their homes and renewable energy.

Thereupon, the Chairman thanked Ms Powell and Ms Thomas-Mears for attending and they both withdrew from the meeting.

RESOLVED that Members distribute the Carmarthenshire Community Challenge information to community groups in their Wards.

451. YOUR HEALTH YOUR FUTURE – PRINCE PHILIP HOSPITAL

(1) WELSH AMBULANCE SERVICES NHS TRUST

Further to Minute No. 408, a letter was received from the Chief Executive, Welsh Ambulance Service NHS Trust (WAST), dated 11 March, 2013, in response to the Council's correspondence to the Health Minister which had been forwarded via the Government Business Team.

The writer stated that WAST's response to Hywel Dda's strategic document "Your Health Your Future" was included on the Health Board's website. He reiterated, however, that WAST felt it premature to meet with the Council until such time as it had a full understanding of the implications of the proposals. WAST was fully committed to engaging with all stakeholders to ensure that any changes improved the quality of the service in a safe and sustainable way. He unreservedly apologized if the Council felt that WAST had been unintentionally discourteous and affirmed that he was fully committed to WAST engaging with the community at all levels.

As well as being disappointed with the content of the letter, Members expressed concern at the existing impact on the ambulance service due to the demands being placed on it with insufficient resources being provided.

Following a discussion, it was

RESOLVED that

- 1. the letter from the Chief Executive of WAST be noted;
- 2. an invitation be extended to WAST to attend a Council meeting to discuss the current situation and ascertain whether the Council would be able to assist in a positive way.

(2) **PROGRESS REPORT**

Cllr. D. M. Cundy declared a personal interest in the following item as he was a Member of the SOSPPAN Campaign Committee.

Further to Minute No. 408, the Deputy Clerk (Administration) provided Members with the Clerk's progress report on events and matters since the last Council meeting.

The Clerk reported on a meeting with Community Health Council (CHC) representatives in Milford Haven on 14 February, 2013, where he presented a joint letter on behalf of Llanelli Rural and Town Councils as further evidence in support of the health board's recommendations being referred to the Health Minister. The meeting was very productive and fulfilled the purpose of submitting further evidence. The letter was received by the CHC's Chairman and Chief Officer and was subsequently emailed to all CHC members. A copy of the letter was also emailed to various Assembly Members across the Mid and West Wales area. Two Assembly Members replied commenting that the health board's recommendations should be referred to the Minister.

A joint meeting had been organised for 14 March, 2013, with Llanelli Rural and Town Council representatives and five Assembly Members including the Llanelli AM and four other regional AMs to discuss the health board's plans for healthcare services and to garner opinions.

The Clerk had also stated that he had attended two meetings organised by the SOSPPAN Campaign Committee on 14 and 28 February, 2013. The SOSPPAN Campaign Committee was looking to obtain Counsel's opinion on the merits of applying for Judical Review and whether there was enough evidence to challenge how Hywel Dda Health Board's consultation phase was conducted. Counsel's fees for providing a definitive opinion was estimated to be in the region of £2,000 to £3,000 plus VAT. SOSPPAN had requested if this cost could be met by Llanelli Rural and Town Councils on a 50:50 basis.

RESOLVED that the information be noted and the Council agree in principle to funding SOSPPAN's fees in obtaining Counsel's opinion in conjunction with Llanelli Town Council as referred to above.
