503. TRALLWM COMMUNITY HALL

Cllr. D. M. Cundy enquired whether the grassed area behind the community hall could be used for extra car parking space.

RESOLVED that the matter be included in the Committee's draft estimates of expenditure for 2014/15.

504. PARK FEES

A letter was received from the Town Clerk, Kidwelly Town Council informing of increased fees and charges that Carmarthenshire County Council had imposed on local sporting organisations using its sports facilities.

Local sporting associations had raised concerns at the impact of increased fees which would also affect the continuing development of youngsters and the other generations that utilise the facilities. The demise of long and well established organisations in the community was also likely.

The writer invited this Council to becoming an integral part of a group to be established with a view to lobbying the County Council should its community be affected. An inaugural meeting of the group would be convened in due course.

Following a discussion during which Members referred to sporting clubs in Dafen, Pwll and Trallwm which would be affected by the increases to be imposed and it was

RESOLVED that the invitation to be part of the group referred to above be accepted.
