**19. MATTERS ARISING**

**(1) MID AND WEST WALES FIRE AND RESCUE AUTHORITY  
DRAFT ANNUAL ACTION PLAN 2013-14**

Further to Minute No 488, (9 April, 2013), the Clerk confirmed that an email had been sent to the Secretary of the Fire Brigade Union placing on record the Council's thanks to the Llanelli Fire Fighters for their service to the community. The email also reminded the recipient about the Council's previous email invitation to attend a future Council meeting. However to date, no reply had been received.

Members expressed disappointment over the lack of response thus far but emphasized they were still keen to meet with the Union. Thereupon Cllr. Donoghue referred to his impending attendance at the Wales TUC Conference in Cardiff. It was anticipated the Fire Brigade Union would be sending representatives and so he promised to make a direct approach to them about attending a future meeting.

**RESOLVED** to await further developments.

**(2) LLANELLI TOWN AND LLANELLI RURAL COUNCILS**

Further to Minute No. 494 (9 April, 2013), Members having requested an update on the situation, the Clerk confirmed that he had corresponded with the Town Clerk along the lines articulated at the previous Council meeting. However, since then the Town Council had made a simple information request about Rural Council budgets and services; this had been addressed via an email exchange with the Town Clerk. However, there had been no further dialogue with the Town Council about areas of collaboration and no formal approach was anticipated for the time being.

**20. YOUR HEALTH YOUR FUTURE – PRINCE PHILIP HOSPITAL**

**PROGRESS REPORT**

Further to Minute No. 491, (9 April, 2013), the Clerk provided Members with a progress report on events and matters since the last Council meeting.

The Clerk confirmed that the matters set out under the resolution contained in Minute No. 491, had been attended too. Members were informed that a letter had been sent to Opinion Research Services, Swansea and also to the Health and Social Services Minister, Welsh Government. The Health Minister replied to the Council's concerns in a letter dated 9 May, 2013, but as anticipated the response was quite general in nature and didn't specifically comment or address any of the Council's concerns. This was disappointing.

**16 May, 2013.**

Members were informed that the Community Health Council (CHC) had sent in a further referral to the Health Minister about concerns over Hywel Dda Health Board plans to reconfigure hospital services. The Minister's letter to the Council also confirmed this but no deadline had been set for determining the referral.

The Clerk commented that since the last meeting he had supplied the SOSPPAN campaign committee with various pieces of information as one of its members was pursuing an application for Judicial Review. It was not clear how this would run in parallel to the CHC's referral to the Minister, should the application for Judicial Review be granted.

The Clerk then referred to the Health Minister's role in dealing with the CHC referral. This meant that the Minister was unable to meet with the Council or any other local stakeholder to listen to any representations the local community might wish to make. The same rule applied to Assembly Members. Therefore no action had been taken in arranging a meeting with the Llanelli Assembly Members and the four other regional Assembly Members because it was unclear given the circumstances whether there was any merit in pursuing a meeting with them if in turn they were unable to make direct representations to the Health Minister over the CHC referral. However, the Clerk confirmed that the situation would be closely monitored and a view taken over what might be the best course of action. In order to facilitate this he requested he be granted delegated powers (in consultation with the Leader of Council) to make whatever arrangements were necessary and to deal with any matters requiring an immediate Council response. Any action taken under delegated powers would be retrospectively reported to Members at the next appropriate opportunity.

During general discussion, the Leader of Council thanked the Clerk for the amount of time being spent on this important ongoing matter and also referred to the closure of the A&E Unit in Newark, Nottingham and the similarities with what might happen at Prince Philip Hospital, Llanelli. He stated death rates in Newark had risen by 37% and felt this was not a coincidence. Members referred to the Welsh Government putting more money into the Ambulance Service but if hospitals were removing beds there was not much point as many of the problems being encountered now would simply be exacerbated and it was

**RESOLVED** that delegated powers be granted to the Clerk in consultation with the Leader of Council to pursue whatever action is deemed appropriate and as circumstances may determine.
