### 279. MEMBERS' DECLARATIONS OF INTEREST

### 280. GRANTS TO SPORTING ORGANISATIONS

Further to Minute No. 231, Members considered the report of the Deputy Clerk (Administration) which referred to the following recommendation of a meeting of the Recreation and Welfare Committee held on 18 October, 2011.

"RECOMMENDED that the Policy and Resources Committee be requested to generally review the Council's grants allocation policy to sporting organisations".

### 281. JOINT WORKING – WINTER PREPAREDNESS

Correspondence was received from the Head of Street Scene, Carmarthenshire County Council, asking for potential help with labour resources in dealing with severe weather.

As a result of the difficult conditions experienced over the last three winters, the writer was asking all town and community councils in Carmarthenshire with a view to putting in place appropriate contingency measures in preparation for the coming winter should we experience another period of severe weather.

The writer was enquiring if the Council had a directly employed labour resource and whether it was prepared to make that resource available to the County Council on request, free of charge, at times of emergencies such as the snow event experienced last January.
