The Council had requested further information from the applicant (via Carmarthenshire County Council) about the proposed change of use and the general use classification. That particular application had been refused following an unsuccessful appeal to the Planning Inspectorate.

Consent was required for change of use from commercial holiday let into a small private residential care home.

374. THE GRANGE FITNESS CLUB, VAUXHALL, LLANELLI

Members were circulated with a neighbour consultation letter received from the Head of Planning, Carmarthenshire County Council, informing of a proposed change of use of The Grange Fitness Club (former gymnasium and health spa). It was proposed to convert the property into open plan offices, together with the reinstatement of the existing café.
