309. MEMBERS' DECLARATIONS OF INTEREST

Cllr. H. J. Evans declared a personal and prejudicial interest in Minute No. 314(2) as a family member worked for Carmarthenshire Youth and Children's Association.

310. PROGRESS REPORT

RESOLVED that the report of the Technical Services Officer on work undertaken, be noted.

311. FELINFOEL COMMUNITY RESOURCE CENTRE CHANGING ROOMS

Members considered the report of the Technical Services Officer informing of the requirement to upgrade the water meter and supply pipework from the highway water main to the entrance gates.

Reports had been received from the rugby and football clubs that there was insufficient water at the shower heads when all the showers were being used.

After an investigation by the M & E Consultant and the heating contractor, they concluded there was insufficient supply of water to feed the system. Following a site meeting with

Welsh Water, it appears that a 32 mm diameter pipe had been installed whereas it should have been a 63 mm diameter pipe.

Welsh Water do not accept any liability and require a further payment of £3,158.67 ex VAT to rectify the fault to change the pipe to a 63 mm diameter pipe. The M & E Consultant had confirmed that design calculations were given to Welsh Water and it was not clear why a smaller water main and meter was installed.

Following discussion, it was

- (2) An architect's instruction be authorised to carry out the said work under the contract for the build:
- (3) a complaint letter be sent to OFWAT over the matter.

312. NOTICE OF PUBLIC PATH DIVERSION ORDER 2011 FFOSLAS RACECOURSE, CARWAY

Members received correspondence from the Head of Leisure & Sport, Regeneration & Leisure Department, Carmarthenshire County Council, informing that a Notice of Public Path Diversion Order 2011 had been made on 7 October, 2011. The effect of the Order would be to divert the public footpath and public bridleway at the former Ffoslas Opencast Mine.

RESOLVED that no objection be made to the proposal.
