As part of its Stage 1 consideration, the National Assembly for Wales' Communities, Equality and Local Government was calling for evidence on the general principles of the Local Government Byelaws (Wales) Bill.

Members having received the views of the Clerk and having previously provided a detailed response to the initial consultation process last year wherein the Council supported the general proposals, it was

## 319. LICENSING ACT 2003 CUMULATIVE IMPACT POLICY STATION ROAD

Cllr. D. J. Davies declared a personal and prejudicial interest in the following matter as he was a Member of the Carmarthenshire County Council Licensing Committee and withdrew from the meeting before discussion commenced.

Members considered a letter from the Principal Licensing Officer, Carmarthenshire County Council informing of the possibility of introducing a Cumulative Impact Policy in respect of Station Road, Llanelli.

The effect of adopting a cumulative impact policy was to create a rebuttable presumption that applications for new premises licences or club premises certificates or variations that were likely to add to the existing cumulative impact in the area specified, would normally be refused following relevant representations. However, if no relevant representations were made in respect of an application, the licensing authority would have to grant the application. Members were informed that if adopted a cumulative impact policy would form part of the Authority's Licensing Policy.

Following discussion it was

**RESOLVED** that the proposal be supported.

### 320. POLICING AND CRIME ACT 2009 SEXUAL ENTERTAINMENT VENUES

Cllr. D. J. Davies declared a personal and prejudicial interest in the following matter as he was a Member of the Carmarthenshire County Council Licensing Committee and withdrew from the meeting before discussion commenced.

Members considered a letter from the Principal Licensing Officer, Carmarthenshire County Council who was undertaking a consultation regarding the adoption of new powers which the Government had introduced which allowed Local Authorities to exercise greater controls over lap dancing clubs and similar premises.

The new legislation allowed Local Authorities to adopt provisions under schedule 3 of the Local Government (Miscellaneous Provisions) Act 1982 to license a new category of premises called Sexual Entertainment Venues.

If adopted, the new provision would allow the authority to consider a wider range of matters than permitted under the four Licensing objectives of the Licensing Act 2003.

Following discussion it was

**RESOLVED** that the proposal be supported.
