393. APOLOGIES FOR ABSENCE

Apologies for absence were received from Cllrs. S. M. Donoghue and T. J. Jones (Cllr. R. E. Evans deputising).

394. MEMBERS' DECLARATIONS OF INTEREST

No declarations of interest were made.

395. YOUTH ENGAGEMENT AND PROGRESSION FRAMEWORK – TIMELINE AND EXECUTIVE GUIDANCE

Members received the Youth Engagement and Progression Framework Implementation Plan from the Welsh Government. This included the pre-engagement initiative that may become funded from April 2014.

The pre-engagement initiative targeted young people who were not ready to progress on to a 21 hours per week scheme. The pre-engagement scheme would not incur added cost as it would mean learners attending scheduled activities already in place.

The Training Manager indicated that there could be an opportunity to become a provider of the pre-engagement scheme across the county with the opportunity to also offer the programme in Carmarthen.

396. COMMUNITIES FIRST-TIME CREDITS IN CARMARTHENSHIRE

Members considered the Communities First-Time Credits scheme received from Spice, an organisation working with Carmarthenshire Communities First to promote time credits within the county.

The Training Manager explained that participants volunteer to earn time credits that can then be spent in the county. The Training Department already offered various activities and courses for which participants could spend time credits. It was also hoping to devise ways in which time credits could be earned on voluntary activities.

Cllr. D. M. Cundy expressed his support for the scheme having received a similar presentation from Spice earlier in the day.

397. OCR QUALIFICATION – SUPPORTING TEACHING AND LEARNING IN SCHOOLS

Members received information about the OCR qualification, Supporting Teaching and Learning in Schools. The Deputy Clerk (Training) explained that this qualification would be delivered in schools targeting teaching assistants.

Interest had already been expressed by schools following a presentation delivered by the Training Department. In the coming months further presentations would be delivered to more schools in the local area.

In response to a question as to whether the presentations could be delivered in Welsh to Welsh medium schools, the Deputy Clerk (Training) confirmed she would make enquiries to ascertain whether the qualification was available in Welsh.
