#### 66. APOLOGIES FOR ABSENCE

**RESOLVED** that a Sub-Committee, comprising the Chairman and Vice-Chairman of Committee, Chairman of Council and Leader of Council be appointed.

#### 69. FINANCIAL REPORTS

**RESOLVED** that the Committee Reports for the Administration and Training Departments to 30 April, 2012, be noted.

#### 70. SCHEDULES OF PAYMENTS

Consideration was given to the Schedules of Payments for the Administration and Training Departments for March and April 2012, (copies of which had been previously circulated) which revealed that the expenditure amounted to £344,629.90 and £326,479.08 and £82,286.41 and £69,821.92 respectively.

#### 71. TRAINING DEPARTMENT

#### (1) FINANCIAL POSITION

Members were circulated with a report from the Training Manager detailing the Training's Department financial position as at the end of the financial year 2011/12.

The Training Manager informed Members that Skills Academy Wales (SAW) had confirmed the money owed to the training department totalling £107,822.39 relating to the financial year 2011/12 would be received in May 2012, with a further £8,708.27 due in June 2012 subject to the approval from the SAW board.

**RESOLVED** that the information be noted.

### (2) ADDITIONAL ACCOMMODATION

Due to the reorganisation of the Training Department last year, the centre at Machynys was re-designated as a Transport Training Centre and a base for the transport assessors. It had become apparent during the last six months that the unit was not large enough to accommodate the assessors and deliver training courses. The Training Manager had sourced quotations from various suitable locations to re-house the four transport assessors in alternative accommodation leaving Machynys to become a fully functional learner centre.

Following discussion, it was

**RESOLVED** that the proposal set out in the report to hire CBSA Centre, Stebonheath be accepted on the following terms:

- (1) the unit cost shall be £450 month (£5,400 per annum) which includes all services, heat and light, water and business rates;
- (2) the unit comprises three rooms and storage space;
- (3) the accommodation includes desks and other office furniture;
- (4) off street parking at the venue; and
- (5) the lease agreement may be terminated by serving one month's notice should there be a need to vacate.
