92. FIVE ROADS RECREATION GROUND – DRAINAGE

Cllr. C. A. Rees declared a personal and prejudicial interest in the following item as the Club Captain of Five Roads Cricket Society was undertaking building works at her home. Cllr. Rees withdrew from the meeting before the matter was discussed.

The Vice-Chairman of Committee, Cllr. L. J. Butler chaired the ensuing item.

Members considered a proposal received from the Club Captain, Five Roads Cricket Society, that the village/cricket team would fund and undertake a small drainage project to reduce water ingress from the field surrounding the cricket square.

A letter of appreciation was also received from the Club Captain for the works completed to date at the recreation ground.

Following discussion, during which Members conveyed their support for the initiative, it was

RESOLVED that the proposal be accepted and the letter of appreciation be noted.

Cllr. Rees returned to chair the remainder of the meeting.

93. PONTYATES WELFARE HALL – HIRE OF FACILITIES

Members were circulated with a letter received from the Treasurer, Pontyates Welfare Association, which informed that, following submissions for payment from the Police Service for the use of the hall's facilities for PACT panel meetings, the Hall Committee were informed that the Service did not have funding available for hire costs.

It was stated that Llangyndeyrn Community Council had offered to pay 50% of said hire costs and a request was being made to this Council to pay the remaining 50%.

Members conveyed their displeasure at the matter and stated that statutory bodies should not be requesting such funding.

RESOLVED that the request not be acceded to.
