# 211. BT'S PROPOSAL TO REMOVE PAYPHONE PROVISION WITHIN CARMARTHENSHIRE – FIRST NOTIFICATION REPORT

Pursuant to Minute No. 146, correspondence was received from the Head of Planning, Carmarthenshire County Council, which included a copy of the 'First Notification' report sent to the Secretary of State in accordance with section 50(1)(b) of the Communications Act 2003. The report contained objections received by the County Council up until 15 August, 2008, to proposals by British Telecommunications plc for the removal of payphones within Carmarthenshire.

Carmarthenshire County Council's consultation period was due to end on 22 August, 2008 and representations received between the date of the above report and 22 August would be entered into the 'Final Notification'.

The following objections to the removal of the telephone kiosk located at Yspitty Road, Bynea, had been submitted and the County Council, having agreed therewith, objected to the removal of said kiosk:-

# 17 September, 2008.

- There was no mobile phone signal in the area
- The retention of this PCB was important for emergencies
- BT's plan to remove 2 PCB's would leave only 2 payphones in the area effectively cutting the service by half; which would be unacceptable

Members having reiterated the above objections, it was
