# 434. APOLOGIES FOR ABSENCE

Apologies for absence were received from Cllrs. T. D. Bowen, S. L. Davies (Cllr. R. G. Thorne deputising), R. E. Evans and M. B. Hughes.

#### 435. MEMBERS' DECLARATIONS OF INTEREST

Cllr. G. H. Wooldridge declared an interest in Minute No. 439 as he was a member of the Saron Community Hall Management Committee.

#### 436. PROGRESS REPORT

**RESOLVED** that the report of the Technical Services Officer on work undertaken, be noted.

### 437. FURNACE COMMUNITY HALL

Members were circulated with a report received from the Technical Services Officer informing of construction progress of the new hall.

**RESOLVED** that the information be noted.

# 438. DAFEN COMMUNITY HALL – EMERGENCY EVACUATION OF HAFAN-Y-COED CARE HOME

A letter was received from the General Manager, Hafan-y-Coed Care Home, Dafen, which referred to a request to use Dafen Hall for emergency evacuation purposes.

### 19 February, 2008.

The writer gave the following confirmation that:-

- Full responsibility for the Care Home's residents would be taken in the event of an evacuation taking place;
- The duration required would depend upon the Senior Fire Officer declaring the Home safe to return to;
- The accommodation required would be the main hall and the use of the kitchen for drinks:
- Social Services had no role or input in providing emergency accommodation and care;
- It would be their responsibility to contact relatives and, if necessary, arrange alternative accommodation in the event that the Home was unsafe to use.

During the ensuing discussion, Members referred to many concerns regarding the request, in particular, the impact upon other users of the hall, the Council's own health and safety aspects, insurance liabilities and risk assessments. Reference was made to a local school as being more suitable premises for such an occurrence. It was suggested that the local Fire Officer and Social Services be contacted for their advice and to enquire as to whether there were reciprocal arrangements with other privately run residential homes.

**RESOLVED** that further investigations be made into the matter accordingly.

# 439. SARON COMMUNITY HALL – COMMEMMORATIVE STONE

Cllr. G. H. Wooldridge declared an interest in the following item as he was a member of the Saron Community Hall Management Committee. Cllr. Wooldridge spoke on the matter but did not vote.

A request was received from the Chairperson, Saron Community Hall Management Committee, for the installation of a commemorative stone in remembrance of those fallen in the First World War.

During discussion, Members suggested that consultation should take place between the Hall Committee, members of the families involved and representatives of the Royal British Legion.

**RESOLVED** that the proposal be supported in principle and to await further developments.

### 440. LUNCHEON CLUBS – INCREASE IN PRICES

A letter was received from the Hotel Services Co-ordinator, Carmarthenshire NHS Trust, informing that it was necessary to increase the cost of meals. It was proposed that the cost of meals supplied to the Senior Citizens' Luncheon Clubs be increased from £2.00 to £2.12 excluding VAT, as from 1 March, 2008.

**RESOLVED** that the proposal be accepted and that the cost of the meals be increased to £2.49 per person (inclusive of VAT) as from 1 March, 2008.
