# 372. PROPOSED DIVERSION OF CILLE STREAM, STRADEY

Members considered email correspondence from Cllr. S. M. Caiach regarding the proposed diversion of the culverted Cille Stream, Stradey. Cllr. Caiach was concerned about the potential detrimental impact diverting the stream might have on the man made lake at Sandy Water Park. Accordingly, Cllr. Caiach was seeking support from the Council to raise the issue with Carmarthenshire Council, seeking an assurance that the diversion of the water course would not have an adverse affect on the lake.
