# 325. DESKTOP PC – REPLACEMENT

The Deputy Clerk (Administration) reported that severe problems had been experienced for some time with a PC in the Administration Department with systems crashing and loss of data. The majority of accounts and payroll activities were processed on this particular machine.

Although there was no budget available to fund a replacement PC it was considered urgent to purchase a new computer immediately. A quotation in the sum of £713.18 plus VAT was received from the Council's IT support consultants, Pisys.net for a new machine. Following consultation with the Chairman of Committee, Chairman of Council and Leader it was agreed to proceed with the purchase given the critical nature of the activities and functions required to be performed on a day to day basis.

**RESOLVED** that the information be noted and the acquisition of the equipment on the grounds of urgency be endorsed.
