168. NUTRITION STRATEGY FOR OLDER PEOPLE IN CARMARTHENSHIRE

Cllrs. T. Devichand and G. H. Wooldridge declared an interest in the following item as Cllr. Devichand was Vice Chairman and Cllr. Wooldridge a member of the Carmarthenshire Health, Social Care and Well-Being Committee. Cllr. Devichand was also a member of the Community Health Council. Neither Member voted on the matter.

The above draft document was received from the Senior Direct Services Manager, Carmarthenshire County Council. It was stated that the document was a result of a multiagency partnership comprising of representation from Carmarthenshire County Council, specifically Education and Children's Services, Social Care and Housing, Carmarthenshire Local Health Board, National Public Health Service for Wales and Carmarthenshire NHS Trust.

During a lengthy discussion, Members fully supported the aims of the strategy and endorsed the charter for improvement and the points contained therein. However, it was recognised that the strategy was aimed at care and residential homes in Carmarthenshire. Members commented that elderly people living on their own could be at a disadvantage when it came to making an informed choice between purchasing nutritious provisions and paying winter fuel bills.

RESOLVED that Members' comments be forwarded to the Senior Direct Services Manager, Carmarthenshire County Council.

169. A STRATEGY FOR SOCIAL SERVICES IN WALES OVER THE NEXT DECADE
