**218.                      COMMUNITY DEVELOPMENT GRANT**

**RESOLVED** that

(1) the following grants be awarded:-

- 1.1 Cylch Meithrin Ponthenri - purchase of new equipment and resources - £800;
- 1.2 Dafen Forum – Arts and Crafts Village Fayre - £2,483.08;

- 1.3 Felinfoel Community Events Committee – restoring Felinfoel’s heritage - £5,000;
- 1.4 Llanelli Blind Bowling Club – club development - £500;
- 1.5 Pwll Action Committee – Blue Plaque scheme for Pwll and Interpretive Panel - £253;
- 1.6 Trallwm Community Playgroup – purchase of learning and play equipment - £435.53

- (2) the grants be released to the successful applicants when costs had been incurred or, in instances where organisations have no balances, an advance of the grant be released and the project monitored;
- (3) publicity be organised to recognise the grants presented to the individual organisations by the Chairman of Council and local Ward Members at the appropriate time and location. If premises were not available, the presentations would take place in the Chairman’s Room;
- (4) future applicants be informed that transport costs would not be supported under the Community Development Fund.
