## 272. RUGBY DEVELOPMENT OFFICER

A report of the Deputy Clerk (Administration) was circulated to Members informing of the charge received from the Welsh Rugby Union for the Rugby Development Officer for the year 2004/05.

The Dragon Rugby Trust, who was responsible for billing the contribution due towards the employment of the Rugby Development Officer prior to the W.R.U., failed to raise an invoice for the year 2004/05. Therefore, the budget of £6,500 was included as an accrued expense at 31 March, 2005. Although the Dragon Rugby Trust had been reminded that a request for the contribution had not been made during 2005/06, an invoice had not been received. Consequently, the amount of £6,500 was not accrued at 31 March, 2006, and the under-spend was included in General Reserves.

**RESOLVED** that an amount of £6,500 be transferred from General Reserves to the Revenue account to offset the expenditure.
