## **390.** SAFER ROUTES FUNDING – LLANELLI WEST SCHEME

Further to Minute No. 325, Members received correspondence from the Transport Planner, Carmarthenshire County Council requesting a letter of support for the Llanelli West safer routes scheme and if possible a match funding commitment for the financial year of 2018/19.

Members were informed that the Welsh Government criteria mentioned that bids including match funding would be looked upon favourably. Therefore, Carmarthenshire County Council had committed  $\pm 10,000$  from its capital budget and correspondence received from Cllr. John P. Jenkins, Llanelli Town Council also confirmed that Llanelli Town Council was contributing  $\pm 5,000$  towards the project.

Following discussion, it was

**RESOLVED** that a letter of support be approved for the scheme but the request for match funding from the Council be declined.

## 391. ADVERTISING (1) LLANELLI AFC

Further to Minute No. 211, Members received email correspondence from Llanelli AFC informing that new larger advertising boards had been fitted at Stebonheath and so the cost for advertising at the ground had risen to £500 from £350 per board.

#### 31 January, 2018

The larger boards were more prominent because they were double the size of the smaller boards and so the Council was asked to consider whether it wanted to pay the extra  $\pounds 150$  to advertise at the ground.

Following discussion, it was

**RESOLVED** that the revised cost of £500 be approved.
