Cemetery and Porterage activities are performed throughout the year. The Council has put in place a preventative maintenance budget based on an annual list of priorities and to cater for day to day contingencies. By adopting a preventative approach this supports sustainable development principles. The cyclical annual maintenance programme ensures community assets are kept in good order, extending the life cycle of the assets over many years.

Good Morning All,

Further from our stakeholders meeting held on the 23rd May 2018, Rob Venus discussed the Precious Plastic project that he is currently involved with.

Attached for your perusal are the details of the Precious Plastic Amman Valley project that Robert Venus has kindly permitted to share with the Pride in Your Patch Stakeholders group, I have been informed that this has now been submitted and are seeking letters to support the concept and highlight any areas for potential partnership working.

This is a micro-scale, community led, plastics recycling project. However, through careful delivery and partnership working the project intends to:

- increase community ownership and concern for their environment.
- improve local issues around loneliness.
- provide opportunities for the community to come together around shared interests.
- work in partnership with other communities in the Amman Valley to improve our environment.
- increase the number and frequency of community litter picks.
- improve community education around Science, Technology, Engineering, Arts and Maths through practical and tangible application.
- create a project pack which can be used by other communities to develop their own Precious Plastic project.

Rob indicated that they aren't out to reinvent the wheel and want to enrich the current community clean-up activities, whilst also highlighting the education aspects of this project and the benefits of making products from waste.

We were asked during the PIYP stakeholders meeting to consider the attached and offer an **email of support**, as they would greatly appreciate the support.

For your info... I've also attached an overview of the current RDP project they are delivering. PRECIOUS PLASTIC AMMAN VALLEY

Development Project Overview

What is Precious Plastic Amman Valley?

The Precious Plastic concept has been proven in numerous projects across the globe. A full overview of the concept can be found within the attached document (About Precious Plastic). However, our proposed version of this project is as follows:

The development of 4 distinct machines, in partnership with University of Wales Trinity Saint

David (UWTSD), which will allow for low cost, localised recycling of waste plastics.

The placement of these machines within a shipping container which will serve as:

1. A community production project where volunteers, vulnerable groups, local creatives and students of all ages can create products from waste materials.

2. A source of income, through the sale of these items, to support further development of

community projects within the Amman Valley.

- 3. An educational venue which will provide a tangible and engaging opportunity to promote recycling, reuse and waste reduction to local schools and people throughout our communities.
- 4. A means of promoting engagement with science, technology, engineering and design which will seek to compliment the work of local schools and colleges whilst promoting these fields to those who may never see themselves engaging with such activities.
- 5. A mobile venue which can be taken to other communities in order to:

Encourage them to develop their own projects similar to this.

- Provide a sense of achievement to the local children who will be invited to come to these other locations and talk about their project
- Enrich other community events by recycling, in real-time, the plastic waste generated at them. E.g. turning drinks bottles into bracelets at a carnival.
- Support community clean-up events by providing an unusual and exciting opportunity to see waste become something functional, decorative or playful.
- The project will be owned by the local community from the earliest stages. Indeed, the concept has resulted from recent consultation within another project being delivered by Cwmaman Town Council. This will continue throughout the project by:

1. Involving local school children in the design of the interior and exterior of the shipping container along with the design of the interpretations board and information sheets.

2. Planned inclusion of volunteering opportunities for local residents within the refitting of the shipping container. E.g. supporting a retired welder to support younger volunteers.

3. Identification and development of Community Champions within the project. These will be volunteers from the local community that develop a passion for the project and can act as advocates for it going forward.

4. Once developed the project will provide on-going volunteering opportunities for local people for years to come. This will be developed in a way which provides the greatest benefit to both the individuals volunteering and to the wider community. Some examples of the ideas proposed during consultation include:

Local young people producing items for sale to support youth projects and events.

Partnership with Shadows (mental health support service) to provide personal development opportunities for their clients whereby they can contribute to their community whilst seeking to overcome their personal barriers within a supportive setting.

 Retired or older residents utilising the skills from their previous employment to make a positive and rewarding contribution to their community; either through the


production of items or by supporting others.

In regards to the process involved, the following stages apply:

- 1. Collection of waste materials through community clean-ups, school collections, community donations or collections and commercial waste streams.
- 2. Processing of materials using plastics identification codes.
- 3. Shredding of plastics using the "Shredding Machine"

4. Storage of materials by type, colour etc.

- 5. Processing of the material into a "Community Product" by using one of the other machines; "The Injections Machine", "The Extruder Machine" or "The Press Moulding Machine".
- 6. Display of the completed "Community Products" at the venue, local craft stores, community venues and on the community website.
- 7. Sale of "Community Products" with all income being used to further develop the project and to support other community activities which may otherwise struggle to be delivered.



- Throughout each of the stages above we will seek to work in partnership with Ysgol y Bedol, Shadows, UWTSD and other key partners to ensure that the maximum return is achieved in regards to education, skills, self-development and environmental sustainability.

The UWTSD Partnership: The School of Engineering at UWTSD have already undertaken the redesign of the machines needed within this project by changing one the projects for their 2nd year Engineering students. Going forward, there is scope for this to develop further through the development of up to 6 internships which will see the students work on the physical manufacture of the machines; a total in-kind support from UWTSD to the project of up to £6,000. This support is not evidenced within the financials of this application as it is dependent upon the students choices and will be used to cover their expenses and materials. However, this is cost that will not be incurred by Precious Plastic Amman Valley for each student who undertakes the project.

"Plastic waste pollution is a huge problem for most countries around the world and one which engineers well placed to help solve. A group of second year students from the school of Engineering at UWTSD are working closely with Cwmaman Town Council to develop a micro plastic recycling plant capable of transforming plastic waste into useful products.

At UWTSD, we actively seek live, real-world projects for our student engineers as we believe it adds authenticity and context to their study. The students are currently developing concept solutions which will then be evaluated and developed into full engineering designs. Internship opportunities will be available for the students to manufacture, test and implement the system. Experiences such as these, really help engineers-intraining to understand the bigger picture and the critical role they can play in society"

 Richard Morgan, Programme Director, School of Engineering University of Wales, Trinity Saint David The Ysgol y Bedol Partnership: A key focus of Cwmaman Town Council in all of its current operations is the Well-being of Future Generations Act (Wales) 2015. As such, providing opportunities to advance the knowledge, aspirations, confidence and feeling of "community belonging" among our younger residents is of high importance. It is our intention to work with the school from the earliest stages of the project and to provide an alternative classroom for them to support the current teaching in areas such as; science, art and design, maths, geography and their work for Eco-School status and other environmental projects.

<u>Keep Wales Tidy:</u> One of the primary objectives of the project is to increase the amount of citizen engagement in cleaning up their communities; and not littering in the first place. As such, we have approached Keep Wales Tidy to ensure that our project blends with existing work in the area, and across Wales, and can work with them in partnership to ensure maximum impact in regards to the issues of littering and pollution.

Simon Peddy, West Wales Regional Manager for Keep Wales Tidy, has offered the following letter of support for the project:

"Keep Wales Tidy fully supports your proposal **Precious Plastics**, and the aim to find innovative community solutions to the problem of waste plastics. We are keen to work in collaboration with the partnership, and if successful support the roll out of this concept to other communities. In particular, we see the following benefits and opportunities;

- Support and development of community clean ups
- Promotion of events and activities across our networks, and potential support in recruiting 'community champions'
 - Involvement of Ysgol y Bedol and opportunities for them to continue to develop through our International Eco-school Programme, and help maintain their Platinum status
 - Potential for other schools on the Eco-schools programme to become engaged if successful
 - Support and advice, if necessary, on waste, recycling and the circular economy
 - To build relationships between local communities, schools and higher education"

<u>CAVS Partnership:</u> We will be working with CAVS to increase volunteer numbers and to ensure the sustainability of the project going forward. Jamie Horton, Rural Volunteering Officer for CAVS, states:

"We are really excited to hear about the **Precious Plastics Project** and its far reaching benefits for the local community. At a time when we are fully recognising the long-term detriment of plastic wastage and pollution this is an excellent catalyst to promote effective recycling, community engagement and a sense of pride and responsibility.

Representing the third sector we view this as an excellent volunteering opportunity, in a rural area of the county, which is both provoking and accessible. This project promotes cross generational volunteering, volunteering for all abilities and has the potential to encourage increased partnership working across our network of third sector organisations.

This sits well within the county's agenda of wellbeing and we are keen to support its fruition."

<u>The Wildlife Trust Support:</u> We have approached the Wildlife Trust to ensure that our project is in keeping with their priorities as the primary agency responsible for the protection of wildlife in our area. Given the focus of the project in reducing plastic pollution and educating community members on the importance of being environmentally conscientious, we look forward to working with them to present a project which can be used across the whole of Wales.

Dr Lizzie Wilberforce, Conservation Manager for the Wildlife Trust, commented:

"Our staff and volunteer spend a significant amount of time undertaking litter picks and beach cleans, including in Carmarthenshire, and we regard the issue as being of significant conservation concern. Plastics are a major component of this waste. On one litter pick in Carmarthenshire we discovered multiple dead small mammals (shrews) inside a bottle that had been discarded on a roadside and within which they had become trapped.

We are particularly supportive of the *Precious Plastic Amman Valley* project because of the support and incentive it provides to collect plastics from the environment and create a more sustainable basis for reducing plastic waste in the community. It will help to change hearts and minds, to regard plastic as a resource instead of a disposable convenience. It will also help physically reduce existing plastic litter in the environment in Carmarthenshire, where it currently creates a hazard for wildlife in the landscape, particularly in rivers like the Amman.

How will the grant be used?

The money secured through this grant application will be used, in conjunction with match funding from Cwmaman Town Council and UWTSD, to:

- Produce each of the machines needed to process the plastic waste into a final "Community Product". We will seek to engage volunteers with the relevant skills in this aspect of the project as we feel that this is in-keeping with the community ownership principle. However, there are some processes and materials needed which will require us to utilise the services of other companies or suppliers. A large portion of this cost, when compared to a purely commercial venture, will also be off-set through the partnership with UWTSD and their Engineering Department. We will also be building these machines as a key part of the project (engagement). In order to maintain the ethos of the project to reuse and reclaim materials, resources and equipment, we will also seek to utilise salvaged components and materials where possible: This will also help to reduce the overall cost of the project.
- Purchase and refurbish a shipping containers. A shipping container is the preferred option as it is highly secure, mobile and very simple/cost effective to modify into a very functional working venue. The lifetime of these units is also significant. As such, should the project no longer be need these units would serve as a valuable asset for the community in another form. Many Precious Plastic models in other countries utilise a 40 foot container as they are often left in one place for a long time. As we hope to transport part or all of our facility to other locations, we have been advised by logistics companies, to purchase two 20 foot containers. This will also allow us more flexibility in regards to placement of the containers at the various sites.
- Purchase and install solar power and batteries. In order to reduce the carbon footprint of the
 project, and support long-term sustainability, we intend to install solar panels and batteries
 which will supply the power required for some of the machines and the lighting, computers and
 other low voltage equipment needed within the space.
- Pay for the production of interpretation boards, information sheets, posters, education worksheets and other print.
- Pay for any electrical works required in order to connect power to the container and safety check the installation once completed.
- **Project Management.** Due to the breadth of the project, and potential for growth, it is seen as essential that hours be included for the deployment of a sub-contracted project manager.
- Workshop Facilitation. In order for schools, community groups and other potential users to be engaged effectively we intend to deliver a series of engagement workshops. These will be facilitated by sessions self-employed specialists with specific knowledge and skills.

Hi Dawn

We have recently been invoiced by PMC (Penygaer Management Committee) for £70 for a football match that was scheduled to be played at our home ground in Trallwm Park, but was switched to Penygaer Playing fields as our pitch was considered unplayable.
