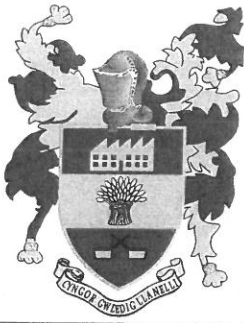

We apologise for the short notice, and look forward to hearing from you at your earliest convenience.

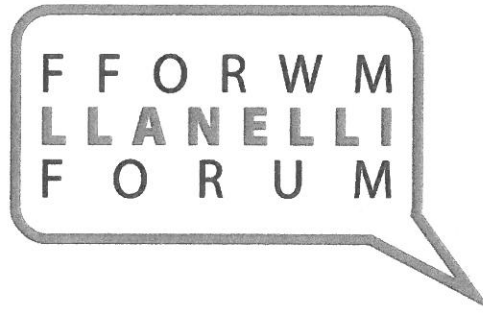

### **THE URDD NATIONAL EISTEDDFOD SIR GAERFYRDDIN 2021**

May I take this opportunity to introduce myself as the Director of the Urdd National Eisteddfod. The Urdd are holding a public meeting next month on **Monday 25 June 2018** to discuss staging the Urdd National Eisteddfod in Sir Gaerfyddin in the year 2021. I would like to extend an invitation to representatives of the Council to the meeting which will be held in **Neuadd y Gwendraeth, Drefach** at **7pm**. Translation facilities will be available.

The Urdd National Eisteddfod annually attracts up to 90,000 visitors, 15,000 competitors and is regarded as the largest youth festival of its kind in Europe. In order to sustain a successful festival, we are dependant on the support of individuals, organisations and institutions on a local and national level. But without local support, it would not be possible for us to stage the festival in its present form and support is paramount to its success both practical and financial. The Urdd Eisteddfod in 2021 will cost in the region of £1.8million.

The aim of the Urdd, which is a registered educational charity, is to provide opportunities and experiences to young children and the youth of Wales, and the forthcoming Eisteddfod will provide an exiting once in a life time opportunities for the children of the area.

The Urdd Eisteddfod is a successful event because of the support we receive from a wide range of different organisations and institutions - public, private and voluntary - both locally and nationally.

There are numerous benefits to the County which stages the event, both cultural and artistic benefits, but there is also a substantial economic benefit. Independent research estimate an economic boost of over £6 million to the economy of the area that welcomes the Urdd National Eisteddfod.

Would it be possible in the near future to arrange a meeting with the councillors, in order that we may discuss the forthcoming Urdd National Eisteddfod and any support that the Council may offer, and maybe give a short presentation to the Council outlining the Urdd Eisteddfod and its benefits. A meeting would be appreciated in order that we may ensure a successful Eisteddfod in Sir Gâr in 2021.

I would like to thank you for your time and hopefully you will draw the councillors attention to the public meeting and hopefully that we may arrange a meeting and address the Council itself. Any financial assistance from your council would be appreciated and would go towards the local appeal committee target, in order that we may provide those opportunities to young children and the youth of this area and throughout Wales.

I look forward in welcoming representatives the public meeting and in hearing from you.

**28. CHILDREN'S BURIAL FEES**

Further to Minute No. 20, Members considered correspondence from Welsh Government dated 7 February 2018 in respect of children's burial fees. The correspondence provided some further clarification on Welsh Government policy since the enactment of the original Memorandum of Understanding on 23 November 2017. However, Members' attention was drawn to consider a particular paragraph which stated therein "*The expectation is that these fees will be waived in all circumstances - including whether the child was a resident of the area or not, and when the intention would be for further interments to be made at a later date.*"

The Secretary commented that the wording had caused an element of doubt amongst burial authorities; the issue being whether it was permissible to charge for future interments in an adult grave space where families had elected to inter a child in the said grave and where the adults then wished to be interred in the same grave at a later date. After a brief discussion it was

**RECOMMENDED** that for the avoidance of doubt the Secretary seek clarification from Welsh Government on the general interpretation of the text in order to properly inform cemetery policy.
