250. MEMBERS' DECLARATIONS OF INTEREST

No declarations of interest were made.

251. WELSH GOVERNMENT'S EMPLOYABILITY PLAN PROGRESS REPORT

As part of the Welsh Government's national strategy, 'Prosperity for All' it had published a cross-government 'Employability Plan' in March 2018. The Plan set out Welsh Government's vision for an economy founded on high quality skills and people with the ability to prosper and the course of action necessary to achieve this.

The plan identified four main themes for action:

- providing an individualised approach to employability support;
- underlining the responsibility of employers to up-skill and support staff;
- responding to current and projected skills' gaps; and
- preparing for a radical shift in the world of work

The Training Manager then proceeded to guide Members through the plan highlighting key figures and actions including the discrepancy between unemployed people in Wales some 71,900 and the current economically inactive population which stood at 339,600.

The rate of economic inactivity in Wales was currently 23.5% compared with 22.5% for the rest of the UK. To reduce the gap in Wales, approximately 18,800 people would need to move into employment. Apprenticeships were the way forward to engage people back into employment thus reducing this gap.

252. PROFESSIONAL STANDARDS FOR FURTHER EDUCATION TEACHERS AND WORK BASED LEARNING PRACTITIONERS IN WALES DOCUMENT – NOVEMBER 2017

The Training Manager provided an overview of this document, which set out the professional standards for further education teachers and work-based learning practitioners in Wales, outlining the background to their development as well as providing guidance and support for implementation and future use.

The Training Manager explained that this had been a successful project after a difficult start and the outcome had been good and highlighted that the strength and quality indicators remained high. During discussion Members thanked the Training Staff for the fantastic job they continued to do with the learners.

2) City and Guilds 30 August, 2018

The data was split over the apprenticeship and traineeship programme areas. The Training Manager stated that the higher apprenticeship figures were low due to the infancy of the scheme. The other apprenticeship areas were satisfactory.
