458. CONSULTATION ON EXTENDING THE CARMARTHENSHIRE COUNTY COUNCIL (DOG CONTROL) PUBLIC SPACES PROTECTION ORDER 2016

Members considered a consultation document from the Waste and Environment Services Division, Carmarthenshire County Council.

The Carmarthenshire County Council (Dog Control) Public Spaces Protection Order 2016 came into force on 1 July, 2016. The Order was made for a period of three years and therefore was due to expire in 2019. The County Council wished to extend the duration of the Order for another three years in accordance with Section 60 of the Anti-Social Behaviour Crime and Policing Act 2014.

Following discussion, Members raised concern that there were insufficient dog warden officers patrolling parks and green spaces.

RESOLVED that the Order be supported and that the Deputy Clerk completes the questionnaire highlighting Members views and observations.
