Members received correspondence from Cllr. S. L. Davies requesting financial assistance for the Llwynhendy and Pemberton Forum foodbank.

Following discussion, it was

**RESOLVED** that a contribution of  $\pounds 1,000$  be made to the Llwynhendy and Pemberton Forum foodbank but any future requests for financial assistance was to be accompanied by supporting financial documentation.

# 327. SANDY AND STRADEY COMMUNITY HALL

*Cllr. M. V. Davies declared a personal interest in the following item as he was a member of the Sandy and Stradey Community Hall Committee. Cllr. P. M. Edwards declared a personal interest in the following item as she was a member of the Sandy and Stradey Community Hall Committee.* 

Correspondence was received from the Secretary, Sandy and Stradey Community Hall requesting permission to change the timer on the boiler at the community hall.

The system would be funded by the community hall and if agreed the control of the heating could be done remotely enabling a more efficient timing system to be put in place to improve the efficiency of the heating system.

Following discussion, it was

**RESOLVED** that the request be supported and the timer controls be changed on the boiler to a smart phone controlled system at the hall.

#### 328. HEART OF WALES LINE TRAIL

Members considered correspondence from the Trail Steering Group, Heart of Wales Line Trail informing of their Action Plan for 2019.

Following discussion, it was

**RESOLVED** that a representative of the Heart of Wales Line Trail be invited to a future meeting of the Recreation and Welfare Committee to give a presentation to members about the proposals set out in the Action Plan.

## 330. CAMBRIAN HERITAGE REGENERATION TRUST (CHRT) LLANELLY HOUSE

The Chairman welcomed to the meeting trustees Alison Evans, Dr. Kevin Jones and Mrs Mary Owens, to discuss the ongoing sustainability of Llanelly House and invited them to address members.

Mrs Evans thanked members for the opportunity to attend the meeting and then guided members through a set of presentation slides highlighting the twenty year project to bring Llanelly House back to life as part of the regeneration of the town centre and also key elements of the revised business plan and the financial support required over the short to medium term.

At the conclusion of the presentation, the Chairman thanked the trustees for attending the meeting and for contributing to a very informative discussion.

The trustees thereupon left the meeting.

Following discussion, it was

**RESOLVED** that the presentation be noted and should a request for financial assistance be followed up and submitted by the trustees that this be respectfully declined for the financial year commencing on 1 April, 2020, however, notwithstanding this, the trustees would be welcome to reapply for financial assistance in the future if so desired.

## 331. FELINFOEL COMMUNITY RESOURCE CENTRE RISK ASSESSMENT

Members considered the fire risk assessment for Felinfoel Community Resource Centre which was provided by a Fire Safety Consultant and former employee of Mid and West Wales Fire Authority.

The Technical and Burial Services Manager informed members about the issues that had evolved at the centre, partly due to the evolution of the use of the building and the occupation of part of the first floor by a sitting tenant, via a lease arrangement entered into with the local management committee.

Following a lengthy discussion about the key steps to be taken it was

**RESOLVED** that members of the Recreation and Welfare sub-committee attend a site meeting at the centre in order to assess the practical issues associated with the use of the building and in support of this initial measure that an invitation be extended to the current tenant to nominate a representative to also attend the site visit to discuss key health and safety issues identified in the Fire Risk Assessment.

## 332. FEASIBILITY STUDY BRIEF LLWYNHENDY LIBRARY

*Cllr. S. L. Davies declared a personal interest in the following item as she was a member of the Llwynhendy Library asset transfer working group in her capacity as a county councillor.* 

Further to Minute No. 233, members considered the report of the Community Development Officer informing of the quotations received for the feasibility study for the development of a community hub building and outdoor space at Llwynhendy Library and Heol Gwili Fields in Llwynhendy.

The Community Development Officer informed the meeting that earlier today members of the Recreation and Welfare sub-committee along with representatives from Invest Local Llwynhendy had the opportunity of selecting a preferred consultant to undertake the task of preparing the feasibility study having conducted a series of interviews with four consultants interested in doing the work.

Following discussion of the deliberations of the sub-committee meeting and having accepted the unanimous recommendation made by the sub-committee about the preferred bid, it was

**RESOLVED** that the quotation received from Chris Jones Regeneration, 32 Chapel Mead, Penperlleni, Monmouthshire in the sum of £14,800 plus VAT be accepted.

The Meeting concluded at 6.35 p.m.

The afore-mentioned Minutes were declared to be a true record of the proceedings and signed by the Chairman presiding thereat and were, on 14 January, 2020, adopted by the Council.
