# 444. EMPLOYABILITY SUPPORT IN WALES

Further to Minute No. 406(2), correspondence was received in the form of a Written Statement from the Minister for Economy and Transport, Welsh Government informing of Employability Support in Wales.

The statement referred to the planned new Job Support Wales programme aimed to amalgamate the five Welsh Government Employability initiatives into a single tailored offer with delivery planned from April 2020.

Following technical issues with a recent procurement exercise, including particular issues around the moderation process leading to final tender scores, the Welsh Government had to revise their approach and the Job Support Wales Programme would not go ahead as originally planned. The existing programmes would all remain in operation until alternatives could be put in place. However, a further statement on progress would be released sometime in March 2020.

## 445. TRAINING DEPARTMENT TRAINEES INCENTIVE PAYMENTS

Members received a report from the Training Manager requesting that incentive bonuses were re-introduced as one of a series of actions designed to improve progression rates in traineeship programmes.

An incentive bonus on receipt of a completed Destination Form had been used effectively in the past to encourage learners to accept progression opportunities and to return a completed form. It was proposed that the incentive was introduced for all progressions from youth programmes.
