Pre-Application Consultation – Town and Country Planning (Development Management Procedure) (Wales) Order 2012 as amended (Temporary Modifications and Disapplication) (Wales) (Coronavirus) Order 20230 Schedule 1 Article 4. (4) Schedule 1B Articles 2C, 2D & 2G - proposed 2 no. Laminar Flow Theatres including stage 1 and 2 recovery areas at Prince Philip Hospital, Llanelli.
