#### 221. APOLOGIES FOR ABSENCE

## 222. MEMBERS' DECLARATIONS OF INTEREST

No declarations of interest were made.

## 223. DYFED POWYS POLICE – NEW POLICING MODEL

The Chairman welcomed Chief Inspector Shaun Bowen, Dyfed Powys Police to the meeting to inform members of the policing model changes being implemented for Carmarthenshire in November 2021.

Chief Inspector Bowen informed members that a management review had been conducted into how the police force dealt with victims of crime and how it managed resources. The police force had to change the way it responded to the public reporting crime. The current system did not always allow the police to work in the best way for victims of crime. The police force had been taking longer than it should to record crime and did not always update victims as regularly as it would wish. Officers had to split their time between investigating tasks and responding to live incidents.

The new Carmarthenshire model would see a local investigation unit (hub) being established in Ammanford and calls would be triaged to it directly from the main call centre. This would enable the public to report crimes which would then be transferred to a dedicated response team located at the central hub, thereby generating a much quicker response to incidents. The central hub would be made up of 19 police officers, comprising 10 officers from Llanelli police station, five officers from Ammanford police station and four officers from Carmarthen police station. In regard to the 10 officers being transferred from Llanelli to the new unit, Chief Inspector Bowen, confirmed this would reduce police force numbers to 45 officers at the police station but it was envisaged these 10 officers would be replaced as a consequence of the Prime Minister's current drive to recruit more police officers throughout the country, bringing the number of officers back to 55 officers at the police station.

Having a dedicated investigation team based in the hub would free up officers to immediately respond to incidents and keep the streets safe. The new model would make reporting and investigating crime quicker and more convenient for victims while increasing the visibility of the police.

Chief Inspector Bowen reassured members that the victims of crime would remain the police force's number one priority and that the public and officers safety was crucial. The new model would not affect neighbourhood policing teams, these units would remain the same; no police stations would close or change and there would be no change to how the police deal with 999 calls. The purpose of the reconfiguration was to be more proactive and to better prioritise crime incidents.

The new model was based on similar structures created elsewhere in the UK and would take effect from 7 November 2021, thereby enabling the reporting and investigating of crime quicker and more convenient for victims. There would be more time for police officers to respond to community concerns and to become more proactive while also supporting victims and witnesses at the scene as well as offering additionality with problem solving.

Chief Inspector Bowen informed members that it was work in progress and the police force would be reviewing the new model over the coming months. The new model would also be scrutinised by chief officers, the Police and Crime Commissioner and by Carmarthenshire communities.

In response to questions from members, Chief Inspector Bowen reiterated there would be no detrimental impact on current police service arrangements and that police officer numbers at Llanelli police station would be reinstated following the national recruitment drive over the next 12 months. In response to when a review of the new model was likely, Chief Inspector Bowen confirmed this would take place at some point in the New Year, when a full evaluation would be performed and which was likely to be led by the Police and Crime Commissioner. In closing he remarked he would be happy to be invited back to the council to go through the evaluation findings with members. Thereupon, the chairman thanked Chief Inspector Bowen for attending the meeting and briefing members and he then withdrew from the meeting.
