#### 437. LLANELLI JOINT BURIAL ADVISORY COMMITTEE

In reference to Minute No. 28, of the Llanelli Joint Burial Advisory Committee meeting held on 25 January, 2022, it was

**RESOLVED** that the following committee recommendation be accepted:

"RECOMMENDED that a budget contribution of £100,000 be requested from Llanelli Rural Council for the financial year 2022 / 2023, and that in turn it requests £50,000 from Llanelli Town Council as its contribution towards service costs.

FURTHER RECOMMENDED that the report recommendations regarding the future use of earmarked reserves be accepted, noting that the current total of earmarked reserves stood at £138,881. Furthermore that the recommendation to transfer a sum of at least £57,904 from general reserves to earmarked reserves in support of a new cemetery compound at year end be accepted".

#### **RESOLVED** that:

- 1. The Council Tax yield of £1,094,894 be levied for the financial year 2022/23 reflecting a 'Band D' charge of £129.83.
- 2. The schedule of works identified in table 1 of the Finance Manager's report in the sum of £117,280 shall be re-tabled for further consideration to a future council meeting following the formation of the new council after the ordinary local government elections to be held in May 2022.

#### 440. ANNUAL INVESTMENT STRATEGY 2022/23

Members considered the council's Annual Investment Strategy prepared in accordance with the statutory guidance as it is applied in Wales and it was

**RESOLVED** that the investment strategy be received and accepted.
