Recommendation – no objection provided:

- 1. The proposed increase in roof height did not significantly alter the character of the original dwelling.
- 2. The flat roof extension when combined with the increase in roof height was subordinate in terms of the collective impact on the overall size and massing of the dwelling.
- 3. There were no issues with the design proposals in terms of compliance with the Local Development Plan general development policies but in particular Policy GP6 Extensions.

Recommendation – objection on the following grounds:

- 1. There were highway safety concerns associated with the access/egress arrangements and the likely placement of the site entrance. If the entrance came off Pen Y Fai Lane it was felt there was not enough scope to accommodate the necessary visibility splays at the site entrance given the narrow breadth of the lane. Moreover, if the access was constructed off the main road there were concerns about its placement directly adjacent to the junction of St Margaret's' Drive. Both options were considered detrimental to highway safety.
- 2. Additional surface water run-off from the proposed dwelling or other impermeable surfaces within the curtilage of the site would exacerbate potential flooding to the lower parts of Stradey Hill during extreme or adverse weather events.
