5. Trallwm Community Hall – to receive correspondence from the hall management committee requesting permission from the council for:
(1) The installation of a defibrillator outside the community hall and to agree the council's response.

The council gives permission to the hall management committee to install a defibrillator outside the community hall.

(2) External hall signage and potential modifications and repairs to the kitchen and two cooker appliances.

A contribution of £300 towards the hall signage be paid to Trallwm Hall Management Committee from the council. The hall management committee to establish if planning consent is a requirement to erect the signage at the hall at a cost to them.

Officers contact the hall management committee to ascertain possible solutions to the works to the kitchen and acquire costs and report back to a future Recreation and Welfare Committee meeting for consideration.
