We will consider how we come across on social media as councils and individuals, what our personal 'digital tone of voice' sounds like, explore our use of language and its role in positive two-way communication, as well as discussing the type of content we can post on social media, depending on our role. For councillors, there are suggested dos and don'ts and how to be effective on social media, whilst considering issues around the Code of Conduct. For officers will explore how the council can demystify the role of the council and showcase its people in order to help pre-emptively deal with negative engagement and attacks.

Having a good understanding of yourself means you'll know what to do when someone tries to push your buttons. In this webinar, we discuss emotional resilience and emotional intelligence and how this applies to specific council situations. Each of the webinars will give real situation scenarios and what to do in each of them.

**\*\*Understanding psychopathic and narcissistic behaviour\*\***

*Delegate fee: £15*

Both psychopathic and narcissistic people generally lack empathy and tend to have unrealistically high opinions of themselves. They often exploit and manipulate others and can be hard to spot as they can also be superficially charming. They are also attracted to roles of power and are often found in leadership positions and in political roles. Real situation scenarios and what to do in each of them will help you spot them and how to monitor your own behaviour to lessen their impact on you and your organisation.

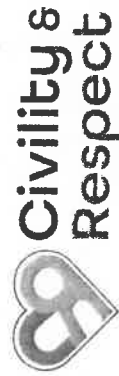

Thank you for the marvellous improvements to the shower system in Pwll. With the catastrophic increase in the costs of energy, it could not have come at a better time. We are all also very pleased from an environmental perspective.

I would be grateful if you could pass on the thanks and appreciation of the committee and users of Pwll Park to the Recreation and Welfare Committee and the whole Rural Council for its ongoing commitment to the Park.

Returning to that word "appreciation" I have the advantage of having served on the Rural Council, and hence a fuller insight into how the model the authority applies brings community wide benefits.

Whilst the committee was able to raise significant funding for the capital costs of the building, the cyclical maintenance and occasional capital investment obligations would have likely resulted in the closure of this popular facility.

There were voices that opposed the arrangement that we came to with the council some years ago now. However, time has illustrated how beneficial our partnership has proved.

We have been able to raise money for the day-to-day revenue needs, and Mark and colleagues have managed the caretaking of the building.

At the same time the council has delivered capital schemes, professionally designed and executed, provided the guidance on regulatory issues particularly beneficial during COVID, and the grounds maintenance.

A division of labour that has borne fruit. It as if the council provides from a community level the assurance that allows facilities to operate at a local level.

I feel it is appropriate to celebrate this latest investment and would be delighted if the council's chair could attend at some stage to "Turn the first tap" and would be grateful if you could liaise with your colleagues over this.

Thank you too for all the work you have undertaken in making this scheme happen, and to Mark G. for his consistent support.
