- 4. Felinfoel Recreation Ground:
 - (1) Felinfoel Resource Centre Re-naming matter requested for inclusion on the agenda by Cllrs. E. Evans and N. Evans

Members were informed that a request had been received to re-name the Felinfoel Resource Centre to the Phil Bennett Resource Centre in memory of Mr Phil Bennett OBE.

It was unanimously agreed to rename the resource centre and officers were instructed to obtain quotations for replacing signage and to register the name change with Carmarthenshire County Council.

(2) Bench – to consider a letter received from the Secretary, Felinfoel RFC for permission to install a bench at the recreation ground in memory of Mr Phil Bennett OBE and to agree the council's response.

That permission be granted in principle but officers shall meet with the club's representative to further discuss the precise location for the bench and the type of materials to be used when constructing bench given the extent of anti-social behaviour experienced at the recreation ground.

5. Five Roads Recreation Ground – matter requested for inclusion on the agenda by Cllr. A. Evans - permission to carry out a project in the recreation ground compromising the construction of a new path around the perimeter also including seats and litter bins together with the planting of trees and hedgerows to be funded by the hall management committee via a grant.

It was agreed to grant permission to the hall management committee to carry out the project.

6. Ponthenri Recreation Ground – matter requested for inclusion on the agenda by Cllr. A. Evans – grant application for lighting and seating and to request whether the council will agree to pay the additional lighting costs.

It was agreed to hold the request in abeyance until such time as the outcome of the Safer Routes in the Community Bid was known because some of the work covered under the grant application could also be covered under the auspices of the bid.

7. Sandy & Stradey Community Hall – Clothes Bank – to consider correspondence from Holibob Charity requesting permission for a clothes bank to situated at the car park at Sandy & Stradey Community Hall.

The request was declined.

8. Swiss Valley Play Area – Erection of a Fence – matter requested for inclusion on the agenda by Cllr. A. G. Morgan

It was agreed that officers investigate costs for the potential provision of a fence for further consideration by the committee. If ultimately the council elected to install a fence then money would need to be identified in next year's financial estimates of income and expenditure.
