#### 9. LLWYNHENDY HUB PROJECT - SITE VISIT TO NEWCASTLE EMLYN BRANCH LIBRARY

Further to Minute No. 237, a site visit was undertaken to the branch library at Newcastle Emlyn to observe the delivery of Carmarthenshire County Council's automated library service and how this possibly could be replicated at Llwynhendy branch library as part of the Llwynhendy Hub project. The Newcastle Emlyn library service had re-located from the former library building to Cawdor Hall. The building was a shared premises and owned by the local town council. The Head of Library Services, Carmarthenshire County Council together with his colleagues, provided a practical demonstration of the service, which was the only one of its kind in Wales.

The automated service made the best use of limited space, while maximising the number of hours the library could operate as it did not need to be manned at all times. It comprised three distinct lockers placed against a single wall, spanning less than three metres in length.

The Head of Library Services explained the service operated much like a vending machine, creating a mini self-service library. Automating the service meant the library could remain open for longer. The self-service reservation pick up lockers, accessed via a person's library card, permitted patrons to reserve items online from the county council's extensive library catalogue. When an item was ready, the item could be picked up from the locker in the library at a time that was convenient to the person making the reservation. Items reserved in this way also could be returned via the locker when items were due for return.

Members were informed that Hublet self-service tablets were also provided to increase digital inclusion. The tablets were proving to be a popular way of accessing library catalogues to order titles that were not immediately available. Patrons could also use them to access the library's other digital services, including audio books, e-books, newspapers and magazines.

The self-service solution had enabled the library to significantly increase service levels, with the library opening from 8.00am to 8.00pm, Monday to Saturday, which was twice as long as before, as well as quadrupling customer visits. Not only were their benefits to the community, but also there have been large improvements for library staff. The self-service products have freed up staff time, enabling them to focus on other tasks, such as engaging with community groups and schools.

Following a general question and answer session, the sub-committee chairman thanked the Head of Library Services for a very informative and worthwhile visit and the party returned to the council offices at Vauxhall Buildings, Llanelli at which point proceedings were concluded.

The site visit concluded at 12.20 p.m.
