3. Community Facilities – Maintenance Works.

4. <u>Dwyfor Growing Spaces – Occupancy Agreement</u> – further to Minute No. 285, to consider the report of the Community Development Officer.

The annual fee per raised bed be set at a hire cost of £20 plus water consumption charges, which shall be recharged to users from the council.
