12. SWISS VALLEY LOWER LLIEDI RESERVOIR OPERATOR LICENCE

Further to Minute No. 415, a meeting was held to consider the tender applications received. Tender invitations had been issued to six providers, having previously registered expressions of interest in undertaking an operator licence to provide water sports and outward bound activities at the Lower Lliedi Reservoir, Swiss Valley. The tender opportunity was also advertised on the council's social media pages and website.

One tender proposal was received, submitted by Livefree Adventures of 26-28 Southernhay East, Exeter, Devon, EX1 1NS. Members were informed that the tender proposal satisfied the operational parameters and maximum pricing for self-launch activities as detailed in the tender invitation. The tender proposal included detailed business case projections, generic operational risk assessments, proof of appropriate insurance and demonstrated the operators qualifications, training and experience in providing water and land based adventure activities. Furthermore, the tender proposal demonstrated awareness of environmental and social issues and detailed initiatives to engage with the community and other stakeholders.
