61. **PUBLIC PARTICIPATION**

There was no public participation in the proceedings.

62. STRADEY PARK HOTEL

Cllr. W. E. Skinner declared a personal and prejudicial interest in the following matter as he was a member of the Planning Committee, Carmarthenshire County Council.

The Chairman welcomed Mr R. Lloyd and Mr S. Williams, members of Furnace Action Committee to the meeting.

Mr Lloyd thanked members for the opportunity to address the council about the Home Office decision to use Stradey Park Hotel to accommodate asylum seekers while their applications were being processed and reviewed, and the impact this would have on the residents living in and around the Llanelli Area. There would also be a detrimental impact on the staff working at the hotel who could potentially lose their jobs.

Mr Lloyd spoke about how and why the Action Committee formed following the news that the Home Office was planning to place 300 asylum seekers at the hotel. The Action Committee wished to object in the strongest possible terms to the Home Office to house asylum seekers at the hotel which played a vital role in Carmarthenshire's tourism policy. The hotel was not suitable for use as accommodation for asylum seekers and put in jeopardy nearly 100 jobs, as well as weddings and other functions that had been booked for the year ahead. Mr Lloyd stated that Carmarthenshire County Council had a preferred model of distributing asylum seekers throughout the wider community and the Action Committee endorsed this.

Mr Lloyd informed members that in an attempt to stop the Home Office using the hotel to house asylum seekers, members of the public could sign a petition which was intended to be delivered to the Prime Minister Rishi Sunak and the Home Secretary Suella Braverman.

Thereupon, Mr Williams stated that as well as the committee voicing its concerns, Nia Griffith MP had also raised her concerns with the Foreign Secretary regarding the large number of investors who had purchased 'blocks' of the hotel.

There then followed a general question and answer session whereby members raised concerns regarding the wellbeing of the large number of asylum seekers who would be staying at the hotel and whether appropriate risk assessments had been undertaken and the general impact of this decision on the already stretched health and ambulance services, as well as education and policing in the area.

Following the conclusion of the question and answer session, the Chairman thanked the committee representatives for a very informative and productive discussion and they then withdrew from the meeting.

Cllr. W. E. Skinner left the meeting

RESOLVED that:

1. The Council fully supports the actions of Furnace Action Committee and shall assist it to publicise its petition through the council's social media channels as well as providing the committee with administrative support if required.

2. A letter of support be sent to the staff at Stradey Park Hotel.

During discussion of the above Cllrs. N. Evans and S. K. Nurse left the meeting.

70. BORROWING APPROVAL 2023 – 24

Members received correspondence from the Welsh Government informing of the council's successful application to borrow £410,000 to support multiple community projects.

The projects were to be delivered across six of the seven electoral wards and would provide for:

- Bynea ward a new play area at Parc Richard, Penygraig;
- Dafen ward a new play area at Cilsaig;
- Felinfoel Ward new toilet facilities at the Phil Bennett OBE Resource Centre, Felinfoel Rereation Ground;
- Glyn ward refurbishment of park and play facilities in Ponthenri;
- Hengoed ward new play area at Stradey;
- Pemberton ward contribution to a community hub project which would involve an asset transfer of the branch library and surrounding green space in the community of Llwynhendy.

Following discussion, it was

RESOLVED that an application be made to the Public Works Loan Board to take out a loan for £410,000 with the repayment terms being taken out as an annuity at an interest rate of 5.53% over a period of four years.
